It is the deliberate 22 act of establishing an emotional connection with a minor through manipulation, trust-building, or influence to 23 facilitate future sexual abuse or exploitation. This includes online or in-person activities, use of third parties, or 24 indirect methods to facilitate the manipulation of a child. 25 "Sexual conduct" means: (C) 26 (i) actual or simulated: 27 (A) sexual intercourse, whether between persons of the same or opposite sex, as defined in 1-1-28 201;
