## CONCURRENT RESOLUTION

To correct the enrollment of S. 2330.

1       *Resolved by the Senate (the House of Representatives*  
2 *concurring)*, That in the enrollment of S. 2330, an Act  
3 to amend the Ted Stevens Olympic and Amateur Sports  
4 Act to provide for congressional oversight of the board of  
5 directors of the United States Olympic and Paralympic  
6 Committee and to protect amateur athletes from emo-  
7 tional, physical, and sexual abuse, and for other purposes,  
8 the Secretary of the Senate shall—  
9           (1) in subsection (b)(2)(D) of section 220504 of  
10       title 36, United States Code, as amended by section  
11       6(b)(2) of the Act, strike “percent”;

1           (2) in subsection (a)(1)(H) of section 220541 of  
2 title 36, United States Code, as added by section  
3 8(a)(1)(B) of the Act, strike “in a manner than”  
4 and insert “in a manner that”;

5           (3) in subsection (f)(4)(B) of section 220541 of  
6 title 36 United States Code, as added by section  
7 8(a)(1)(E) of the Act, insert “and the Committee on  
8 the Judiciary” after “the Committee on Energy and  
9 Commerce”;

10           (4) amend paragraph (1) of section 220541(g)  
11 of title 36, United States Code, as added by section  
12 8(a)(1)(E) of the Act, to read as follows:

13           “(1) MANDATORY PAYMENTS.—

14           “(A) FISCAL YEAR 2021.—On January 4,  
15 2021, the corporation shall make a mandatory  
16 payment of \$20,000,000 to the Center for oper-  
17 ating costs of the Center for fiscal year 2021.

18           “(B) SUBSEQUENT FISCAL YEARS.—For  
19 fiscal year 2022 and each fiscal year thereafter,  
20 the corporation shall make a mandatory pay-  
21 ment of \$20,000,000 to the Center not later  
22 than the close of business on the first regular  
23 business day in January.”; and

24           (5) in subsection (h)(2)(C)(iii) of section  
25 220541 of title 36, United States Code, as added by

1 section 8(a)(1)(E) of the Act, insert “and the Com-  
2 mittee on the Judiciary” after “the Committee on  
3 Energy and Commerce”.
