A BILL

To provide protection for survivors of domestic violence or sexual assault under the Fair Housing Act.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fair Housing for Do-
- 5 mestic Violence and Sexual Assault Survivors Act of
- 6 2019".
- 7 SEC. 2. FINDINGS.
- 8 Congress makes the following findings:

1	(1) Cities, towns, and rural communities in the
2	United States continue to face enormous challenges
3	regarding domestic violence, sexual assault, dating
4	violence, stalking, and other forms of intimate part-
5	ner violence.
6	(2) One in 3 women have experienced rape
7	physical violence, or stalking by an intimate partner
8	in their lifetime.
9	(3) Approximately 7,000,000 women are raped
10	or physically assaulted by a current or former inti-
11	mate partner each year.
12	(4) Each day, an average of 3 women are killed
13	by a current or former partner.
14	(5) Researchers estimate that domestic violence
15	costs employers up to $$13,000,000,000$ each year.
16	(6) A fundamental component of ending domes-
17	tic and sexual violence is securing safe and afford-
18	able housing for victims.
19	(7) Research indicates that—
20	(A) nearly 50 percent of all homeless
21	women report that domestic violence was the
22	immediate cause of their homelessness;
23	(B) 92 percent of homeless women report
24	having experienced severe physical or sexual vi-

olence at some point in their lives;

1	(C) victims become homeless as a result of
2	sexual assault, and once homeless, are vulner-
3	able to further sexual victimization and exploi-
4	tation;
5	(D) women of color in the lowest income
6	category experience 6 times the rate of nonfatal
7	intimate partner violence compared to white
8	women in the highest income category;
9	(E) poor women of color, domestic violence
10	victims, and women with children have a high
11	risk of eviction; and
12	(F) approximately 38 percent of all victims
13	of domestic violence become homeless at some
14	point in their life.
15	(8) Surveys show that a majority of victims who
16	experience a sexual assault in their home do not re-
17	locate to a safe environment because they do not
18	have sufficient funds and are not aware of better op-
19	tions.
20	(9) Domestic and sexual violence victims often
21	find themselves trapped in homes where they are
22	further victimized by caregivers, parents, siblings,
23	landlords, intimate partners, neighbors, or others in
24	or near their home. Economic insecurity and the

trauma that often follows sexual assault make it dif-

- ficult, if not impossible, for many victims to access safe, affordable housing options for themselves and their families.
 - (10) Domestic and sexual violence victims continue to face discrimination in securing and maintaining housing based on their status as victims and as a result of crimes committed against them.
 - (11) Research by the Attorney General of the State of New York found that 67 percent of domestic violence victims reported that discrimination by landlords is a significant obstacle in obtaining housing.
 - (12) Research also shows that victims of domestic violence or sexual assault are commonly denied housing opportunities if a previous residence of the victim was a domestic violence shelter, if the victim has secured a protective order, or if there is other evidence that the victim has experienced a previous domestic violence incident.
 - (13) Studies show that victims of domestic violence or sexual assault often face eviction based on a single domestic violence incident.
 - (14) It is in the public interest to ensure that victims of domestic violence, sexual assault, dating violence, stalking, and other forms of intimate part-

1	ner violence are not discriminated against, particu-
2	larly with respect to housing, based on their status
3	as victims or the crimes committed against them.
4	(15) Nothing in this Act should be interpreted
5	to limit the ability of victims of domestic violence or
6	sexual assault to recover for claims of discrimination
7	on the basis of sex or race under the Fair Housing
8	Act (42 U.S.C. 3601 et seq.), including with respect
9	to failure to conform to gender stereotypes or poli-
10	cies that disproportionately affect women.
