AN ACT

- To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to make grants to entities that provide legal services for homeless veterans and veterans at risk for homelessness, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Legal Services for
3	Homeless Veterans Act".
4	SEC. 2. LEGAL SERVICES FOR HOMELESS VETERANS AND
5	VETERANS AT RISK FOR HOMELESSNESS.
6	(a) In General.—Chapter 20 of title 38, United
7	States Code, is amended by inserting after section 2022
8	the following new section:
9	"§ 2022A. Legal services for homeless veterans and
10	veterans at risk for homelessness
11	"(a) Grants.—Subject to the availability of appro-
12	priations provided for such purpose, the Secretary of Vet-
13	erans Affairs shall make grants to eligible entities that
14	provide legal services to homeless veterans and veterans
15	at risk for homelessness.
16	"(b) Criteria.—(1) The Secretary shall—
17	"(A) establish criteria and requirements for
18	grants under this section, including criteria for enti-
19	ties eligible to receive such grants; and
20	"(B) publish such criteria and requirements in
21	the Federal Register.
22	"(2) In establishing criteria and requirements under
23	paragraph (1), the Secretary shall—
24	"(A) take into consideration any criteria and
25	requirements needed with respect to carrying out

this section in rural communities, Tribal lands, and

3	"(B) consult with organizations that have expe-
4	rience in providing services to homeless veterans, in-
5	cluding veterans service organizations, the Equa
6	Justice Works AmeriCorps Veterans Legal Corps
7	and other organizations the Secretary determines
8	appropriate.
9	"(c) Eligible Entities.—The Secretary may make
10	a grant under this section to an entity applying for such
11	a grant only if the applicant for the grant—
12	"(1) is a public or nonprofit private entity with
13	the capacity (as determined by the Secretary) to ef-
14	fectively administer a grant under this section;
15	"(2) demonstrates that adequate financial sup-
16	port will be available to carry out the services for
17	which the grant is sought consistent with the appli-
18	cation;
19	"(3) agrees to meet the applicable criteria and
20	requirements established under subsection $(b)(1)$
21	and
22	"(4) has, as determined by the Secretary, dem-
23	onstrated the capacity to meet such criteria and re-
24	quirements.

1	"(d) USE OF FUNDS.—Grants under this section
2	shall be used to provide homeless veterans and veterans
3	at risk for homelessness the following legal services:
4	"(1) Legal services related to housing, including
5	eviction defense, representation in landlord-tenant
6	cases, and representation in foreclosure cases.
7	"(2) Legal services related to family law, in-
8	cluding assistance in court proceedings for child sup-
9	port, divorce, estate planning, and family reconcili-
10	ation.
11	"(3) Legal services related to income support,
12	including assistance in obtaining public benefits.
13	"(4) Legal services related to criminal defense,
14	including defense in matters symptomatic of home-
15	lessness, such as outstanding warrants, fines, and
16	driver's license revocation, to reduce recidivism and
17	facilitate the overcoming of reentry obstacles in em-
18	ployment or housing.
19	"(5) Legal services related to requests to up-
20	grade the characterization of a discharge or dis-
21	missal of a former member of the Armed Forces
22	under section 1553 of title 10.

"(6) Such other legal services as the Secretary

determines appropriate.

- 1 "(e) Funds for Women Veterans.—For any fiscal
- 2 year, not less than 10 percent of the amount authorized
- 3 to be appropriated for grants under this section shall be
- 4 used to provide legal services described in subsection (d)
- 5 to women veterans.
- 6 "(f) Reports.—On a biennial basis, the Secretary
- 7 shall submit to the Committees on Veterans' Affairs of
- 8 the House of Representatives and the Senate a report on
- 9 grants under this section. To the extent feasible, each such
- 10 report shall include the following with respect to the year
- 11 covered by the report:
- 12 "(1) The number of homeless veterans and vet-
- erans at risk for homelessness assisted.
- 14 "(2) A description of the legal services pro-
- vided.
- 16 "(3) A description of the legal matters ad-
- dressed.
- 18 "(4) An analysis by the Secretary with respect
- to the operational effectiveness and cost-effectiveness
- of the services provided.".

5	(a) In General.—The Secretary of Veterans Affairs
6	shall complete an analysis of programs of the Department

9	the areas in which such programs are failing to meet the
10	needs of such women.
11	(b) Report.—Not later than 270 days after the date
12	of the enactment of this Act, the Secretary shall submit
13	to the Committee on Veterans' Affairs of the Senate and
14	the Committee on Veterans' Affairs of the House of Rep-
15	resentatives a report on the analysis completed under sub-
16	section (a).
