1 A RESOLUTION adjourning the Senate in honor and loving memory of Dr. 2 William R. Markesbery. 3 WHEREAS, William R. Markesbery was a son of this Commonwealth, having been 4 born in Florence, Kentucky, on September 30, 1932; and 5 WHEREAS, William Markesbery was a veteran of the United States Army. After 6 returning to Kentucky, he entered the first medical school class at the University of 7 Kentucky in 1960 and graduated with distinction in 1964; and 8 WHEREAS, completing his residency at Columbia-Presbyterian Hospital, Dr. 9 Markesbery went on to join the faculty at the University of Rochester School of Medicine 10 and Strong Memorial Hospital; and 11 WHEREAS, it was a love of basketball that brought Dr. Markesbery back to 12 Kentucky. He joined the faculty at the University of Kentucky in 1972 and would go on 13 to develop one of the first 10 Alzheimer's Disease Research Centers; and 14 WHEREAS, Dr. Markesbery would become the director of the University of 15 Kentucky's Sanders-Brown Center on Aging, and his commendations and awards for his 16 work in the fields of aging and Alzheimer's research are vast. In 1981, he and 17 collaborators published the first of several studies that explored the causes and symptoms 18 of Alzheimer's, and for this and many other landmark publications he would procure 19 National Institutes of Health funding for more than three decades, and published 410 20 peer-reviewed scientific articles; and 21 WHEREAS, it is appropriate that this body honor those physicians and researchers 22 who make a profound impact in their field, and whose work resonates for years after they 23 have passed from this life; and 24 WHEREAS, Dr. William R. Markesbery is thus honored on this day for his work in 25 the field of Alzheimer's research, and the members of this august body rightfully 26 acknowledge his passing on January 30, 2010;
