## A BILL ENTITLED

1 AN ACT concerning

2 **Universities at Shady Grove Regional Higher Education Center**

3 FOR the purpose of establishing the Universities at Shady Grove Regional Higher  
4 Education Center; establishing the purpose of the Center; requiring certain  
5 programs to be offered at the Center; providing for the funding of the Center; altering  
6 a certain definition; and generally relating to the Universities at Shady Grove  
7 Regional Higher Education Center.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
24 That the Laws of Maryland read as follows:

**Article – Education**

12–101.

(b) (1) In this title the following words have the meanings indicated.

(3) “Centers” or “institutes” means the following components of the System under the jurisdiction of the Board of Regents:

(i) University of Maryland Center for Environmental Science;

(ii) Cooperative Extension Service and the Agricultural Experiment Station;

(iii) Statewide Medical Education and Training System;

(iv) Fire and Rescue Institute;

(v) Center for Maryland Advanced Ventures;

(vi) University of Maryland Center for Economic and Entrepreneurship Development;

**(VII) UNIVERSITIES AT SHADY GROVE REGIONAL HIGHER EDUCATION CENTER; and**

**[(vii)] (VIII)** Any other center, component, or institute established and operated by the System in accordance with its mission.

12–119.

**(A) THERE IS A UNIVERSITIES AT SHADY GROVE REGIONAL HIGHER EDUCATION CENTER WITHIN THE UNIVERSITY SYSTEM OF MARYLAND.**

**(B) THE PURPOSE OF THE UNIVERSITIES AT SHADY GROVE REGIONAL HIGHER EDUCATION CENTER IS TO PROVIDE STUDENTS ACCESS TO ESTABLISHED, CUTTING EDGE, AND HIGH–DEMAND ACADEMIC PROGRAMS OF DEGREE–GRANTING INSTITUTIONS.**

**(C) THE ACADEMIC PROGRAMS OFFERED AT THE UNIVERSITIES AT SHADY GROVE REGIONAL HIGHER EDUCATION CENTER SHALL BE UPPER DIVISION UNDERGRADUATE AND GRADUATE LEVEL PROGRAMS.**

**(D) FUNDING FOR THE UNIVERSITIES AT SHADY GROVE REGIONAL**

1 HIGHER EDUCATION CENTER SHALL BE AS PROVIDED IN THE STATE BUDGET.

2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
3 1, 2020.
