20 Subject to Title 10, Subtitle 2 of the Criminal Procedure Article AND (a) (1) SUBSECTION (E) OF THIS SECTION, a fire department or rescue squad of the State or a 22 political subdivision of the State, a volunteer fire company or rescue squad, or an 23ambulance service licensed under § 13–515 of the Education Article may request the State Fire Marshal or other authorized agency that has access to the Criminal Justice

- 4 member, or paramedic AFTER THE APPLICANT'S FIRST IN-PERSON INTERVIEW.
- 5 (2) The request shall be made on the form required by the State Fire 6 Marshal.
- 7 (b) (1) An applicant for employment or appointment as a volunteer or career 8 firefighter, rescue squad member, or paramedic shall provide a classifiable set of 9 fingerprints in accordance with paragraphs (2) and (3) of this subsection:
- 10 (i) for submission to the Criminal Justice Information System 11 Central Repository for a criminal history records check; and
- 12 (ii) for forwarding to the Federal Bureau of Investigation for a 13 national criminal history records check.
- 14 (2) The applicant shall provide the fingerprints on a form approved by the 15 Director of the Criminal Justice Information System Central Repository.
- 16 (3) (i) On request of the State Fire Marshal or an appropriate authority 17 designated by rule of the State Fire Marshal, the applicant shall provide the fingerprints 18 to the State Fire Marshal or the designated authority.
- 19 (ii) In a jurisdiction that has designated an assistant State fire 20 marshal, on request of the assistant State fire marshal an applicant in the jurisdiction shall 21 provide the fingerprints to the assistant State fire marshal.

- 5 (I) BE COMPOSED OF EMPLOYEES OF THE FIRE DEPARTMENT,
- 6 RESCUE SQUAD, OR AMBULANCE SERVICE;
- 7 (II) MEET WITH EACH APPLICANT FOR WHOM THE CRIMINAL
- 8 HISTORY RECORDS CHECK PRODUCES RECORDS OF A CONVICTION OR AN ARREST;
- 9 (III) ALLOW AN APPLICANT TO EXPLAIN THE APPLICANT'S

- 12 (IV) MAKE RECOMMENDATIONS TO THE FIRE DEPARTMENT,
- 13 RESCUE SQUAD, OR AMBULANCE SERVICE REGARDING EMPLOYMENT OR
- 14 APPOINTMENT OF AN APPLICANT WHO HAS MET WITH THE COMMITTEE REGARDING
