A BILL

- To direct the Secretary of Veterans Affairs to carry out a grant program for veterans to become appraisers for home loans under chapter 37 of title 38, United States Code.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Stop Discrimination
 - 5 Against Veteran Home Buyers Act".
 - 6 SEC. 2. GRANT PROGRAM FOR APPRAISERS.
 - 7 (a) Grant Program.—The Secretary of Veterans
 - 8 Affairs shall carry out a two-year grant program for vet-

- 1 erans to become VA home loan appraisers. The grant pro-
- 2 gram shall be known as the "Veterans Serving Veterans
- 3 Appraiser Program".
- 4 (b) Eligible Entities.—The Secretary may award
- 5 a grant under subsection (a) to any of the following:
- 6 (1) A congressionally chartered veterans service
- 7 organization.
- 8 (2) A State, local, or Tribal veterans service
- 9 agency.
- 10 (3) A nonprofit organization that has histori-
- 11 cally served veterans housing needs.
- 12 (4) A nonprofit entity that the Secretary deter-
- mines has a demonstrated history of community en-
- 14 gagement.
- 15 (5) Any other entity the Secretary determines
- 16 appropriate.
- 17 (c) Amount; Frequency.—A grant awarded under
- 18 subsection (a) may not exceed \$500,000. The Secretary
- 19 may not award more than one grant to a single eligible
- 20 entity.
- 21 (d) Use of Funds.—An entity that is awarded a
- 22 grant under subsection (a) shall use such grant to estab-
- 23 lish and carry out training programs for veterans to be-
- 24 come VA home loan appraisers.

1	(e) REGULATIONS.—The Secretary shall prescribe
2	regulations to carry out this section, including with respect
3	to the evaluation of applications for grants awarded under
4	subsection (a). Such evaluation shall prioritize eligible en-
5	tities that will use the grant on programs to train veterans
6	who will become VA home loan appraisers in the county
7	in which the veteran resides.
8	(f) Report.—Not later than one year after the date
9	on which the grant program under subsection (a) com-
10	mences, the Secretary of Veterans Affairs shall submit to
11	the Committee on Veterans' Affairs of the Senate and the
12	Committee on Veterans' Affairs of the House of Rep-
13	resentatives a report on—
14	(1) the number of veterans participating in a
15	training program to become a VA home loan ap-
16	praiser pursuant to such grant program; and
17	(2) the types and locations of the entities that
18	have been awarded a grant.
19	(g) VA HOME LOAN APPRAISER DEFINED.—In this
20	section, the term "VA home loan appraiser" means an ap-
21	praiser described in section 3731(a)(3) of title 38, United
