BY repealing and reenacting, without amendments, Article – Transportation Section <u>11-117.2</u> and 11-134.5 Annotated Code of Maryland (2012 Replacement Volume and 2019 Supplement) BY adding to Article – Transportation Section 18.7–101 and 18.7–102 to be under the new title "Title 18.7. Motor Scooter and Electric Low Speed Scooter Sharing Companies" Annotated Code of Maryland (2012 Replacement Volume and 2019 Supplement)
