1 AN ACT concerning

2 **Special Vehicle Registration Plates – Chesapeake Bay Trust and Maryland**
3 **Agricultural Education Foundation – Appropriation**

4 FOR the purpose of requiring the Governor to include in the annual budget bill for certain
5 fiscal years an appropriation for the Chesapeake Bay Trust and Maryland
6 Agricultural Education Foundation, Inc. that is calculated based on the amount of
7 revenue collected from certain special vehicle registration plates in certain fiscal
8 years, adjusted for inflation; and generally relating to funding for the Chesapeake
9 Bay Trust and Maryland Agricultural Education Foundation.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 6 That the Laws of Maryland read as follows:

7 **Article – Transportation**

8 13–618.

9 (a) The Administration shall issue a special Chesapeake Bay Commemorative
 10 Registration Plate.

11 (c) (2) (iv) Any surplus money remaining after the Administration has
 12 recovered the costs of issuing a commemorative plate under this section and money
 13 collected for additional renewal fees may not be retained by or transferred to any agency of
 14 the State for any purpose.

15 (v) Notwithstanding subparagraph (iv) of this paragraph, the
 16 surplus money and money collected for additional renewal fees shall be disbursed by the
 17 Administration to the Chesapeake Bay Trust.

18 **(VI) BEGINNING IN FISCAL YEAR 2025, AND FOR EACH FISCAL**
 19 **YEAR THEREAFTER, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL**
 20 **AN AMOUNT FOR THE CHESAPEAKE BAY TRUST EQUAL TO THE AVERAGE AMOUNT**
 21 **DISBURSED UNDER SUBPARAGRAPH (V) OF THIS PARAGRAPH ~~IN THE THIRD~~**

29 (a) In consultation with the Maryland Agricultural Education Foundation, Inc.
 30 the Administration shall develop and make available for qualifying vehicles a specially
 31 designed registration plate honoring Maryland agriculture.

32 (d) **(1)** The Administration shall consult with the Maryland Agricultural
 33 Education Foundation, Inc. on:

34 **[(1)] (I)** The design of a registration plate to be issued under this section
 35 to honor Maryland agriculture;

1 [(2)] (II) The setting of the fee to be charged under subsection (c)(1)(ii) of
2 this section at a level intended to encourage the purchase of the registration plate issued
3 under this section while providing a continuous revenue source to benefit the Foundation;
4 and

5 [(3)] (III) A schedule under which the Administration will transfer to the
6 Foundation revenue collected on the Foundation’s behalf.

7 (2) BEGINNING IN FISCAL YEAR 2025, AND FOR EACH FISCAL YEAR
8 THEREAFTER, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN
9 AMOUNT FOR THE MARYLAND AGRICULTURAL EDUCATION FOUNDATION, INC.
10 EQUAL TO THE AVERAGE AMOUNT DISBURSED UNDER PARAGRAPH (1)(III) OF THIS
11 SUBSECTION ~~IN THE THIRD IMMEDIATELY PRECEDING~~ FROM FISCAL YEAR 2017
12 THROUGH FISCAL YEAR 2022, ADJUSTED FOR INFLATION BY THE CONSUMER PRICE
13 INDEX CPI-U FOR ALL URBAN CONSUMERS FOR THE BALTIMORE METROPOLITAN
14 STATISTICAL AREA, LESS THE AMOUNT DISBURSED UNDER PARAGRAPH (1)(III) OF
15 THIS SUBSECTION IN THE ~~SECOND~~ IMMEDIATELY PRECEDING FISCAL YEAR IF THE
16 DIFFERENCE IS A POSITIVE NUMBER.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
18 1, 2023.
