Apprenticeships – Apprenticeship and Training Council – Revisions

FOR the purpose of requiring the Division of Workforce Development and Adult Learning to adopt regulations to carry out certain provisions of law; providing that the Division is the designated State Apprenticeship Agency under certain provisions of federal law; altering the duties of the Apprenticeship and Training Council; prohibiting certain persons from taking certain actions regarding apprenticeship programs for certain occupations unless the program is first approved by the Division, rather than the Council; requiring that a certain certificate be issued by the Division, rather than jointly by the Council and the Division; providing for certain judicial review if the <u>Division does not issue a certain certificate</u>; authorizing the Division, rather than the Council, to suspend or revoke approval of to deregister a program or course, rather than the Council suspending or revoking the approval of a program or course. under certain circumstances; authorizing certain persons to request a hearing before the United States Department of Labor under certain circumstances; authorizing the Division, rather than the Council, to adopt certain rules and regulations under certain circumstances; authorizing the Council to recommend that the Division apply to a certain court for a certain injunction; authorizing the Division to apply to a certain court for a certain injunction under certain circumstances; requiring the Division to accord reciprocal approval to certain apprentices, apprenticeship programs, and standards that are registered in other states under certain circumstances; prohibiting the Division from according reciprocal approval to a program sponsor that does not meet certain requirements and standards; authorizing the Council to recommend that the Division negotiate and adopt certain

- (a) THE DIVISION OF WORKFORCE DEVELOPMENT AND ADULT LEARNING IS THE DESIGNATED STATE APPRENTICESHIP AGENCY UNDER TITLE 29, C.F.R. PARTS 29 AND 30.
- 10 **(B)** (1) There is an Apprenticeship and Training Council as part of the Division of Workforce Development and Adult Learning. The Council consists of 12 members all of whom shall be appointed by the Governor of Maryland, with the advice of the Secretary and with the advice and consent of the Senate of Maryland.
 - (2) Four of the members shall be representatives of employee organizations; one shall be an employee; five shall be representatives of employers; and two shall be appointed from the general public.
 - (3) The membership of the Council shall, to the extent practicable, reflect the geographic, racial, ethnic, cultural, and gender diversity of the State and shall include representation by individuals with disabilities. Consultants to the Council shall, to the extent practicable, reflect the geographic, racial, ethnic, cultural, and gender diversity of the State and shall include representation by individuals with disabilities.
- 22 (4) In advising the Governor, the Secretary shall give consideration to a 23 balanced geographic representation from all of Maryland and a representative sampling 24 and mix of Maryland industry.
- 25 (5) One member shall be appointed as Chairman by the Governor, with the advice of the Secretary, and serve as Chairman at the pleasure of the Governor. The Assistant State Superintendent, Career and Technology Education, and the Maryland State Director of the Office of Apprenticeship, U.S. Department of Labor, shall serve as consultants to the Council without vote.
- 30 (6) The Governor, with the advice of the Secretary may appoint up to three 31 additional consultants to the Council from the public at large.
- 32 [(b)] (C) All appointments as members of the Council shall be for terms of 4 33 years.
- [(c)] (D) (1) Except as provided in paragraph (2) of this subsection and subject to paragraph (3) of this subsection, a member shall be considered to have resigned

- 1 if the member did not attend at least two-thirds of the Council meetings held during any consecutive 12-month period while the member was serving on the Council.
- 3 (2) The Governor may waive a member's resignation and allow the member 4 to continue serving if the member has been unable to attend meetings for reasons 5 satisfactory to the Governor and the reasons are made public.
- 6 (3) In accordance with § 8–501 of the State Government Article, the 7 Chairman shall provide notice to the Governor and the Governor shall appoint a successor.

- (b) (1) No person, firm, or corporation may offer, establish, maintain, or operate an apprenticeship program for any occupation approved by the [Council and recognized by the] Division of Workforce Development and Adult Learning as an apprenticeable occupation for which tuition, charges, or fees are charged to or are payable by an enrollee or student, or which is financed in whole or in part by State funds, unless the program is first approved by the [Council or the Secretary under subsection (d) of this section] **DIVISION OF WORKFORCE DEVELOPMENT AND ADULT LEARNING**.
- 15 (2)(I)The [Council and the] Division of Workforce Development and 16 Adult Learning [jointly] shall issue a certificate of approval to an applicant operating or 17 proposing to operate the program if Ithey are satisfied, or the Secretary under subsection (d) of this section THE DIVISION OF WORKFORCE DEVELOPMENT AND ADULT 18 19 **LEARNING** is satisfied[,] that the conditions of entrance, the qualifications of the 20 administrators and instructors, the content of the program, the facilities, and the financial 21aspects of the program are adequate and appropriate for the purpose of the program.
- 22 (II) IF THE DIVISION OF WORKFORCE DEVELOPMENT AND
 23 ADULT LEARNING DOES NOT ISSUE A CERTIFICATE OF APPROVAL TO AN APPLICANT
 24 OPERATING OR PROPOSING TO OPERATE A PROGRAM, ANY PERSON, FIRM, OR
 25 CORPORATION WHOSE APPLICATION IS REJECTED HAS A RIGHT TO JUDICIAL
 26 REVIEW UNDER TITLE 10, SUBTITLE 2 OF THE STATE GOVERNMENT ARTICLE.
- 27 (3) (I) The [Council] DIVISION OF WORKFORCE DEVELOPMENT
 28 AND ADULT LEARNING, after notice and hearing, may suspend or revoke its approval of
 29 DEREGISTER a program or course if it[, or the Secretary under subsection (d) of this
 30 section,] finds that the program or course has ceased to meet the conditions of approval.
- 31 (II) ANY PERSON, ASSOCIATION, COMMITTEE, OR
 32 ORGANIZATION THAT OPERATES AN APPRENTICESHIP PROGRAM THAT IS
 33 DEREGISTERED BY THE DIVISION OF WORKFORCE DEVELOPMENT AND ADULT
 34 LEARNING MAY REQUEST A HEARING BEFORE THE UNITED STATES DEPARTMENT
 35 OF LABOR.

- 1 (4) Any person, firm, or corporation whose application for approval is 2 rejected or whose certificate of approval is suspended or revoked has a right of judicial 3 review as provided in the Administrative Procedure Act.
- (5) [Except as otherwise provided in this section,] AFTER CONSULTING the Council, [in consultation with] the Division of Workforce Development and Adult Learning, after notice and hearing, may adopt rules and regulations for the implementation of this section, including rules and regulations requiring the furnishing of periodic relevant information about approved and proposed programs and the operator or proposed operator of the approved or proposed programs.
- 10 (6) (5) Any person, firm, or corporation that knowingly offers, establishes, maintains, or operates a program in violation of this section is guilty of a misdemeanor and, upon conviction, shall be fined not more than \$1,000 or be imprisoned for not more than one year, or both.
- 14 (7) (I) The Council[, consistent with the approval of the Division of
 15 Workforce Development and Adult Learning, in addition, shall] MAY RECOMMEND THAT
 16 THE DIVISION OF WORKFORCE DEVELOPMENT AND ADULT LEARNING apply to any
 17 court of competent jurisdiction for an injunction restraining violations of this section.
- 18 (H) (6) IF RECOMMENDED BY THE COUNCIL UNDER
 19 SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE DIVISION OF WORKFORCE
 20 DEVELOPMENT AND ADULT LEARNING MAY APPLY TO ANY COURT OF COMPETENT
 21 JURISDICTION FOR AN INJUNCTION RESTRAINING VIOLATIONS OF THIS SECTION.
- 22 **(1)** EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS (c) **(I)** 23PARAGRAPH, THE DIVISION OF WORKFORCE DEVELOPMENT AND ADULT 24LEARNING SHALL ACCORD RECIPROCAL APPROVAL TO APPRENTICES, 25APPRENTICESHIP PROGRAMS, AND STANDARDS THAT ARE REGISTERED IN OTHER 26 STATES BY THE UNITED STATES DEPARTMENT OF LABOR'S OFFICE OF 27 APPRENTICESHIP OR A REGISTRATION AGENCY, IF RECIPROCITY IS REQUESTED BY 28 THE APPRENTICESHIP PROGRAM SPONSOR.
- 29 (II) THE DIVISION OF WORKFORCE DEVELOPMENT AND ADULT
 30 LEARNING MAY NOT ACCORD RECIPROCAL APPROVAL TO A PROGRAM SPONSOR
 31 THAT DOES NOT MEET THE WAGE AND HOUR REQUIREMENTS AND APPRENTICE
 32 RATIO STANDARDS OF THE RECIPROCAL STATE.
- 33 (2) The Council [, consistent with the approval of the Division of Workforce 34 Development and Adult Learning,] may RECOMMEND THAT THE DIVISION OF 35 WORKFORCE DEVELOPMENT AND ADULT LEARNING negotiate and adopt agreements 36 permitting reciprocity with apprenticeship and training councils of another state, or the 37 United States Department of Labor, Office of Apprenticeship.

- 1 (2) (3) If recommended by the Council under paragraph 2 (1) of this subsection, the Division of Workforce Development and 3 Adult Learning may negotiate and adopt agreements permitting 4 reciprocity with apprenticeship and training councils of another 5 state, or the United States Department of Labor, Office of 6 Apprenticeship.
- 7 (d) **[**(1) If a disagreement arises between the Council and the Division of Workforce Development and Adult Learning, as a result of a vote taken by the Council with 9 respect to any of the duties and responsibilities in subsections (a) through (c) of this section, 10 the Council may designate three Council members who voted in the majority to present the 11 position of the Council to the Secretary for consideration of the issue on which the Council and the Division disagree.

- 16 (3) (i) After consideration of the positions of the Council and the Division of Workforce Development and Adult Learning, the Secretary shall issue a final decision on the issue.
- 19 (ii) The final decision issued under subparagraph (i) of this 20 paragraph shall be the final agency decision.
- 21 (4) If a party other than the Council or the Division of Workforce 22 Development and Adult Learning is aggrieved by the decision of the Secretary, the party 23 shall be entitled to judicial review as provided in the Administrative Procedure Act.

- 30 (ii) the age, race, sex or gender identity, county of residence, and 31 program enrollment of each individual enrolled in a registered apprenticeship program.

- 34 (i) sort the information required under paragraph (1) of this 35 subsection by apprenticeship program; and
