# A BILL

To approve an agreement between the United States and the Republic of Palau, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. APPROVAL OF THE AGREEMENT BETWEEN THE
4	UNITED STATES AND THE REPUBLIC OF
5	PALAU.
6	(a) DEFINITIONS.—In this section:
7	(1) AGREEMENT.—The term "Agreement"
8	means the Agreement and appendices signed by the
9	United States and the Republic of Palau on Sep-
10	tember 3, 2010.
11	(2) COMPACT OF FREE ASSOCIATION.—The
12	term "Compact of Free Association" means the
13	Compact of Free Association between the Govern-
14	ment of the United States of America and the Gov-
15	ernment of Palau (48 U.S.C. 1931 note; Public Law
16	99–658).
17	(b) RESULTS OF COMPACT REVIEW.—
18	(1) In General.—Title I of Public Law 99–
19	658 (48 U.S.C. 1931 et seq.) is amended by adding
20	at the end the following:
21	"SEC. 105. RESULTS OF COMPACT REVIEW.
22	"(a) In General.—The Agreement and appendices
23	signed by the United States and the Republic of Palau
24	on September 3, 2010 (referred to in this section as the
25	'Agreement'), in connection with section 432 of the Com-

- 1 pact of Free Association between the Government of the
- 2 United States of America and the Government of Palau
- 3 (48 U.S.C. 1931 note; Public Law 99–658) (referred to
- 4 in this section as the 'Compact of Free Association'), are
- 5 approved—
- 6 "(1) except for the extension of Article X of the
- 7 Agreement Regarding Federal Programs and Serv-
- 8 ices, and Concluded Pursuant to Article II of Title
- 9 II and section 232 of the Compact of Free Associa-
- tion; and
- "(2) subject to the provisions of this section.
- 12 "(b) WITHHOLDING OF FUNDS.—If the Republic of
- 13 Palau withdraws more than \$9,000,000 from the trust
- 14 fund established under section 211(f) of the Compact of
- 15 Free Association in fiscal year 2018, amounts payable
- 16 under sections 1, 2(a), 3, and 4(a), of the Agreement shall
- 17 be withheld from the Republic of Palau until the date on
- 18 which the Republic of Palau reimburses the trust fund for
- 19 the total amounts withdrawn that exceeded \$9,000,000 in
- 20 that fiscal year, except that funds to be provided under
- 21 section 3 of the Agreement may be released to replenish
- 22 the 211(f) Fund if an arrangement had been made be-
- 23 tween the United States and the Republic of Palau to ad-
- 24 vance funds during such fiscal year from the 211(f) Fund

- 1 for the purposes allowable under section 3 of the Agree-
- 2 ment.
- 3 "(c) Funding for Certain Provisions Under
- 4 Section 105 of Compact of Free Association.—Not
- 5 later than 30 days after the date of the enactment of this
- 6 section, out of any funds in the Treasury not otherwise
- 7 appropriated, the Secretary of the Treasury shall transfer
- 8 to the Secretary of the Interior such sums as are necessary
- 9 for the Secretary of the Interior to implement sections 1,
- 10 2(a), 3, 4(a), 5, and 6 of the Agreement, which sums shall
- 11 remain available until expended without any further ap-
- 12 propriation.
- 13 "(d) Authorizations of Appropriations.—There
- 14 are authorized to be appropriated—
- 15 "(1) to the Secretary of the Interior to sub-
- sidize postal services provided by the United States
- 17 Postal Service to the Republic of Palau, the Repub-
- lic of the Marshall Islands, and the Federated States
- of Micronesia, \$1,500,000 for each of fiscal years
- 20 2018 through 2024, to remain available until ex-
- 21 pended but may be available pursuant to this para-
- graph to the United States Postal Service only so
- long as domestic postage may be used for mail to
- Palau, the Federated States of Micronesia, and the
- 25 Republic of the Marshall Islands; and

- 1 "(2) to the head of each Federal entity de-
- 2 scribed in paragraphs (1), (3), and (4) of section
- 3 221(a) of the Compact of Free Association (includ-
- 4 ing the successor of each Federal entity) to carry
- 5 out the responsibilities of the Federal entity under
- 6 section 221(a) of the Compact of Free Association
- 7 such sums as are necessary, to remain available
- 8 until expended.".
- 9 (2) Offset.—Section 3 of the Act of June 30,
- 10 1954 (68 Stat. 330, 82 Stat. 1213, chapter 423), is
- 11 repealed.
- 12 (c) Payment Schedule; Withholding of Funds;
- 13 Funding.—
- 14 (1) COMPACT SECTION 211(f) FUND.—Section
- 15 1 of the Agreement shall be construed as though the
- section reads as follows:
- 17 "SEC. 1. COMPACT SECTION 211(f) FUND.
- 18 "The Government of the United States shall con-
- 19 tribute \$30,250,000 to the Fund referred to in section
- 20 211(f) of the Compact in accordance with the following
- 21 schedule:
- "(1) \$22,000,000 in fiscal year 2018.
- 23 "(2) \$2,000,000 in each of fiscal years 2019
- 24 through 2022.
- "(3) \$250,000 in fiscal year 2023.".

1	(2) Infrastructure maintenance fund.—				
2	Subsection (a) of section 2 of the Agreement shall				
3	be construed as though the subsection reads as fol-				
4	lows:				
5	"(a) The Government of the United States shall pro-				
6	vide a grant of \$16,000,000 in fiscal year 2018, rep-				
7	resenting the amounts to have been provided by the				
8	United States in fiscal years 2011 through 2017 under				
9	section 2(a) of the Agreement, and a grant of \$2,000,000				
10	annually from the beginning of fiscal year 2019 through				
11	fiscal year 2024 to create a trust fund, to be known as				
12	the 'Infrastructure Maintenance Fund', to be used for the				
13	routine and periodic maintenance of major capital im-				
14	provement projects financed by funds provided by the				
15	United States. The Government of the Republic of Palau				
16	shall match the contributions made by the United States				
17	by making contributions of \$150,000 to the Infrastructure				
18	Maintenance Fund on a quarterly basis from the begin-				
19	ning of fiscal year 2018 through fiscal year 2024. Imple-				
20	mentation of this subsection shall be carried out in accord-				
21	ance with the provisions of Appendix A of this Agree-				
22	ment.".				
23	(3) FISCAL CONSOLIDATION FUND.—Section 3				
24	of the Agreement shall be construed as though the				
25	section reads as follows:				

### 1 "SEC. 3. FISCAL CONSOLIDATION FUND.

- 2 "The Government of the United States shall provide
- 3 the Government of Palau \$10,000,000 in fiscal year 2018
- 4 for deposit in an interest bearing account to be used to
- 5 reduce government arrears of Palau. Implementation of
- 6 this section shall be carried out in accordance with the
- 7 provisions of Appendix B of this Agreement.".
- 8 (4) DIRECT ECONOMIC ASSISTANCE.—Sub-
- 9 section (a) of section 4 of the Agreement shall be
- 10 construed as though the subsection reads as follows:
- 11 "(a) In addition to the economic assistance of
- 12 \$13,147,000 provided to the Government of Palau by the
- 13 Government of the United States in each of fiscal years
- 14 2010, 2011, 2012, 2013, 2014, 2015, 2016, and 2017,
- 15 and unless otherwise specified in this Agreement or in an
- 16 Appendix of this Agreement, the Government of the
- 17 United States shall provide the Government of Palau
- 18 \$27,250,000 in economic assistance as follows:
- "(1) \$7,250,000 in fiscal year 2018.
- 20 "(2) \$6,000,000 in fiscal year 2019.
- "(3) \$5,000,000 in fiscal year 2020.
- "(4) \$4,000,000 in fiscal year 2021.
- 23 "(5) \$3,000,000 in fiscal year 2022.
- 24 "(6) \$2,000,000 in fiscal year 2023.
- 25 The funds provided in any fiscal year under this sub-
- 26 section for economic assistance shall be provided in 4

- 1 quarterly payments (30 percent in the first quarter, 30
- 2 percent in the second quarter, 20 percent in the third
- 3 quarter, and 20 percent in the fourth quarter) unless oth-
- 4 erwise specified in this Agreement or in an Appendix of
- 5 this Agreement.".
- 6 (5) Infrastructure projects.—Section 5 of
- 7 the Agreement shall be construed as though the sec-
- 8 tion reads as follows:

### 9 "SEC. 5. INFRASTRUCTURE PROJECTS.

- 10 "The Government of the United States shall provide
- 11 in fiscal year 2018, \$40,000,000 to the Government of
- 12 Palau towards one or more mutually agreed infrastructure
- 13 projects in accordance with the provisions of Appendix C
- 14 to this Agreement.".
- 15 (d) Continuing Programs and Laws.—Section
- 16 105(f)(1)(B)(ix) of the Compact of Free Association
- 17 Amendments Act of 2003 (48 U.S.C. 192ld(f)(1)(B)(ix))
- 18 is amended by striking "2009" and inserting "2024".
- 19 (e) Audit; Full Faith and Credit; Inflation
- 20 Adjustment.—The Secretary of the Interior shall fund
- 21 the amounts necessary to conduct the audits required by
- 22 section 6 and Appendix D of the Agreement. Section 236
- 23 of the Compact applies to the commitments of the United
- 24 States under sections 1, 2(a), 3, 4(a), and 5 of the Agree-
- 25 ment, and to the amounts necessary to conduct such au-

- 1 dits, to the same extent as section 236 applies to the Com-
- 2 pact. Section 215 of the Compact shall be applied to such
- 3 commitments and amounts by substituting "2010" for
- 4 "1981".
- 5 (f) Passport Requirement.—Section 141 of Arti-
- 6 cle IV of Title One of the Compact of Free Association
- 7 shall be construed and applied as if it read as follows:
- 8 "SEC. 141. PASSPORT REQUIREMENT.
- 9 "(a) IN GENERAL.—An individual in one of the fol-
- 10 lowing categories may be admitted to lawfully engage in
- 11 occupations and establish residence as a nonimmigrant in
- 12 the United States and its territories and possessions with-
- 13 out regard to paragraphs (5) or (7)(B)(i)(II) of section
- 14 212(a) of the Immigration and Nationality Act (8 U.S.C.
- 15 1182(a)(5) or (a)(7)(B)(i)(II), if the passport presented
- 16 to satisfy section 212(a)(7)(B)(i)(I) of such Act is a valid,
- 17 unexpired, machine-readable passport that satisfies the
- 18 internationally accepted standard for machine readability:
- 19 "(1) An individual who, on September 30,
- 20 1994, was a citizen of the Trust Territory of the Pa-
- cific Islands, as defined in title 53 of the Trust Ter-
- 22 ritory Code in force on January 1, 1979, and has
- become and remains a citizen of Palau.

1	"(2) An individual who acquires the citizenship					
2	of Palau, at birth, on or after the effective date of					
3	the Constitution of Palau.					
4	"(3) A naturalized citizen of Palau, who has					
5	been an actual resident of Palau for not less than					
6	five years after attaining such naturalization an					
7	who holds a certificate of actual residence.					
8	"(b) Employment.—An individual in one of the cat-					
9	egories in paragraphs (1) through (3) of subsection (a)					
10	shall be considered to have the permission of the Secretary					
11	of Homeland Security of the United States to accept em-					
12	ployment in the United States.					
13	"(c) Habitual Residence.—The right of an indi-					
14	vidual in one of the categories in paragraphs (1) through					
15	(3) of subsection (a) to establish habitual residence in a					
16	territory or possession of the United States may be sub-					
17	jected to non-discriminatory limitations provided for—					
18	"(1) in statutes or regulations of the United					
19	States; and					
20	"(2) in those statutes or regulations of the ter-					
21	ritory or possession concerned which are authorized					
22	by the laws of the United States.					
23	"(d) Clarification.—Subsection (a)—					
24	"(1) does not confer on a citizen of Palau the					
25	right to establish the residence necessary for natu-					

1	ralization under the Immigration and Nationality
2	Act, or to petition for benefits for alien relatives
3	under that Act; and
4	"(2) shall not prevent a citizen of Palau from
5	otherwise acquiring such rights or lawful permanent
6	resident alien status in the United States.".
