- 1 (1) is employed in a position affected by this Act on July 1, 2020; and
- 2 (2) has no creditable service in the Employees' Pension System before July 3 1, 2008.
- 4 (b) An individual described under subsection (a) of this section shall have the 5 individual's service credit from the Employees' Pension System transferred and combined 6 with the individual's service in the Correctional Officers' Retirement System.
- 7 (c) If an individual described under subsection (a) of this section is granted an 8 ordinary disability benefit under Title 29, Subtitle 1 of the State Personnel and Pensions 9 Article, the Board of Trustees for the State Retirement and Pension System shall calculate 10 the ordinary disability benefit under §§ 29–106 and 29–108 of the State Personnel and 11 Pensions Article and grant the greater benefit to the individual.
