Mr. Chabot introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To amend title 36, United States Code, to revise the Federal charter for the Foundation of the Federal Bar Association.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Foundation of the Fed-
- 5 eral Bar Association Charter Amendments Act of 2017".
- 6 SEC. 2. ORGANIZATION.
- 7 Section 70501 of title 36, United States Code, is
- 8 amended by striking subsection (b) and redesignating sub-
- 9 section (c) as subsection (b).

SEC. 3. MEMBERSHIP.

- 2 Section 70503 of title 36, United States Code, is
- 3 amended—
- 4 (1) by striking subsections (a) and (b) and in-
- 5 serting the following:
- 6 "(a) Eligibility.—Except as provided in this chap-
- 7 ter, eligibility for membership in the corporation and the
- 8 rights and privileges of members are as provided in the
- 9 bylaws.";
- 10 (2) by redesignating subsection (c) as sub-
- section (b); and
- 12 (3) by adding at the end the following:
- 13 "(c) Nondiscrimination.—The terms of member-
- 14 ship may not discriminate on the basis of race, color, reli-
- 15 gion, sex, disability, age, sexual orientation, or national
- 16 origin.".
- 17 SEC. 4. GOVERNING BODY.
- 18 Section 70504 of title 36, United States Code, is
- 19 amended to read as follows:
- 20 **"§ 70504. Governing body**
- 21 "(a) Board of Directors.—The board of directors
- 22 is the governing body of the corporation. The board may
- 23 exercise, or provide for the exercise of, the powers of the
- 24 corporation. The board of directors and the responsibilities
- 25 of the board are as provided in the bylaws.

- 1 "(b) Officers.—The officers and the election of the
- 2 officers are as provided for in the bylaws.
- 3 "(c) Nondiscrimination.—The requirements for
- 4 serving as a director or officer may not discriminate on
- 5 the basis of race, color, religion, sex, disability, age, sexual
- 6 orientation, or national origin.".

7 SEC. 5. RESTRICTIONS.

- 8 Section 70507 of title 36, United States Code, is
- 9 amended to read as follows:

10 **"§ 70507. Restrictions**

- 11 "(a) Stock and Dividends.—The corporation may
- 12 not issue stock or declare or pay a dividend.
- 13 "(b) POLITICAL ACTIVITIES.—The corporation or a
- 14 director or officer in his or her corporate capacity may
- 15 not contribute to, support, or participate in any political
- 16 activity or in any manner attempt to influence legislation.
- 17 "(c) Distribution of Income or Assets.—The in-
- 18 come or assets of the corporation may not inure to the
- 19 benefit of, or be distributed to, a director, officer, or mem-
- 20 ber during the life of the charter granted by this chapter.
- 21 This subsection does not prevent the payment, in amounts
- 22 approved by the board of directors, of—
- 23 "(1) reasonable compensation; or

- 1 "(2) reimbursement for expenses incurred in
- 2 undertaking the corporation's business, to officers,
- directors, or members.
- 4 This subsection does not prevent the award of a grant to
- 5 a Federal Bar Association chapter of which an officer, di-
- 6 rector, member may be a member. This subsection also
- 7 does not prevent the payment of reasonable compensation
- 8 to the corporation's employees for services undertaken on
- 9 behalf of the corporation.
- 10 "(d) Loans.—The corporation may not make a loan
- 11 to a director, officer, member, or employee.
- 12 "(e) Immunity From Liability.—Members and pri-
- 13 vate individuals are not liable for the obligations of the
- 14 corporation.
- 15 "(f) Claim of Governmental Approval or Au-
- 16 THORITY.—The corporation may not claim congressional
- 17 approval or the authority of the United States Govern-
- 18 ment for any of its activities; it may, however, acknowl-
- 19 edge this charter.".
- 20 SEC. 6. PRINCIPAL OFFICE.
- 21 Section 70508 of title 36, United States Code, is
- 22 amended by striking "the District of Columbia," and in-
- 23 serting "a United States location decided by the board of
- 24 directors and specified in the bylaws,".

1 SEC. 7. SERVICE OF PROCESS.

- 2 Section 70510 of title 36, United States Code, is
- 3 amended to read as follows:
- 4 "§ 70510. Service of process
- 5 "The corporation shall comply with the law on service
- 6 of process of the State or District in which it is incor-
- 7 porated.".
- 8 SEC. 8. DEPOSIT OF ASSETS ON DISSOLUTION OR FINAL
- 9 **LIQUIDATION.**
- 10 Section 70512 of title 36, United States Code, is
- 11 amended to read as follows:
- 12 "§ 70512. Deposit of assets on dissolution or final liq-
- 13 **uidation**
- 14 "On dissolution or final liquidation of the corpora-
- 15 tion, any assets of the corporation remaining after the dis-
- 16 charge of all liabilities shall be distributed as provided by
- 17 the board of directors, but in compliance with the charter
- 18 and bylaws.".
