Ms. NORTON introduced the following bill; which was referred to the Committee on Oversight and Reform

### A BILL

- To direct the Mayor of the District of Columbia to establish a District of Columbia National Guard Educational Assistance Program to encourage the enlistment and retention of persons in the District of Columbia National Guard by providing financial assistance to enable members of the National Guard of the District of Columbia to attend undergraduate, vocational, or technical courses.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

## 1SECTION 1. DISTRICT OF COLUMBIA NATIONAL GUARD2EDUCATIONAL ASSISTANCE PROGRAM.

3 The Act entitled "An Act to provide for the organiza4 tion of the militia of the District of Columbia", approved
5 March 1, 1889 (sec. 49–101 et seq., D.C. Official Code)
6 is amended by adding at the end the following new title:

# 7 **"TITLE II—EDUCATIONAL**8 **ASSISTANCE PROGRAM**

### 9 "SEC. 201. SHORT TITLE; FINDINGS.

10 "(a) SHORT TITLE.—This title may be cited as the
11 'Major General David F. Wherley, Jr. District of Colum12 bia National Guard Retention and College Access Act'.

13 "(b) FINDINGS.—Congress makes the following find-14 ings:

15 "(1) The District of Columbia National Guard
16 is under the exclusive jurisdiction of the President of
17 the United States as Commander-in-Chief and, un18 like other National Guards, is permanently federal19 ized.

"(2) The District of Columbia National Guard
is unique and differs from the National Guards of
the several States in that the District of Columbia
National Guard is responsible, not only for residents
of the District of Columbia, but also for a special
and unique mission and obligation as a result of the

extensive presence of the Federal Government in the
 District of Columbia.

3 "(3) Consequently, the President of the United
4 States, rather than the chief executive of the Dis5 trict of Columbia, is in command of the District of
6 Columbia National Guard, and only the President
7 can call up the District of Columbia National Guard
8 even for local emergencies.

9 "(4) The District of Columbia National Guard 10 has been specifically trained to address the unique 11 emergencies that may occur regarding the presence 12 of the Federal Government in the District of Colum-13 bia.

"(5) The great majority of the members of the
District of Columbia National Guard actually live in
Maryland or Virginia, rather than in the District of
Columbia.

18 "(6) The District of Columbia National Guard
19 has been experiencing a disproportionate decline in
20 force in comparison to the National Guards of Mary21 land and Virginia.

"(7) The States of Maryland and Virginia provide additional recruiting and retention incentives,
such as educational benefits, in order to maintain
their force, and their National Guards have drawn

1 recruits from the District of Columbia at a rate that 2 puts at risk the maintenance of the necessary force levels for the District of Columbia National Guard. 3 "(8) Funds for an educational benefit for mem-4 5 bers of the District of Columbia National Guard 6 would provide an incentive to help reverse the loss 7 of members to nearby National Guards and allow for 8 maintenance and increase of necessary District of 9 Columbia National Guard personnel. 10 "(9) The loss of members of the District of Co-11 lumbia National Guard could adversely affect the 12 readiness of the District of Columbia National 13 Guard to respond in the event of a terrorist attack 14 on the capital of the United States. 15 "SEC. 202. DISTRICT OF COLUMBIA NATIONAL GUARD EDU-16 CATIONAL ASSISTANCE PROGRAM. 17 "(a) Educational Assistance Program Author-IZED.—The Mayor of the District of Columbia, in coordi-18 19 nation with the commanding general of the District of Columbia National Guard, shall establish a program under 20 21 which the Mayor may provide financial assistance to an 22 eligible member of the District of Columbia National 23 Guard to assist the member in covering expenses incurred 24 by the member while enrolled in an approved institution 25 of higher education to pursue the member's first undergraduate, masters, doctoral, vocational, or technical de gree or certification.

3 "(b) ELIGIBILITY.—

4 "(1) CRITERIA.—A member of the District of
5 Columbia National Guard is eligible to receive assist6 ance under the program established under this title
7 if the commanding general of the District of Colum8 bia National Guard certifies to the Mayor the fol9 lowing:

10 "(A) The member has satisfactorily com11 pleted required initial active duty service.

"(B) The member has executed a written
agreement to serve in the District of Columbia
National Guard for a period of not less than 6
years.

16 "(C) The member is not receiving a Re-17 serve Officer Training Corps scholarship.

18 "(2) MAINTENANCE OF ELIGIBILITY.—To con19 tinue to be eligible for financial assistance under the
20 program, a member of the District of Columbia Na21 tional Guard must—

"(A) be satisfactorily performing duty in
the District of Columbia National Guard in accordance with regulations of the National
Guard (as certified to the Mayor by the com-

1	manding general of the District of Columbia
2	National Guard);
3	"(B) be enrolled on a full-time or part-time
4	basis (seeking to earn at least 3, but less than
5	12 credit hours per semester) in an approved
6	institution of higher education; and
7	"(C) maintain satisfactory progress in the
8	course of study the member is pursuing, deter-
9	mined in accordance with section 484(c) of the
10	Higher Education Act of 1965 (20 U.S.C.
11	1091(c)).
12	"SEC. 203. TREATMENT OF ASSISTANCE PROVIDED.
13	"(a) Permitted Use of Funds.—Financial assist-
14	ance received by a member of the District of Columbia
15	National Guard under the program under this title may
16	be used to cover—
17	((1) tuition and fees charged by an approved
18	institution of higher education involved;
19	((2) the cost of books; and
20	"(3) laboratory expenses.
21	"(b) Cap on Amount of Assistance.—
22	"(1) IN GENERAL.—The amount of financial
23	assistance provided to a member of the District of
24	Columbia National Guard under the program may
25	not exceed the following:

1	"(A) In the case of fees and laboratory ex-
2	penses, \$500 per year.
3	"(B) In the case of books, \$500 per year.
4	"(C) In the case of tuition, \$10,000 per
5	year.
6	"(2) Adjustments in case of insufficient
7	FUNDING.—If the Mayor determines that the
8	amount available to provide assistance under this
9	title in any year will be insufficient, the Mayor may
10	reduce the maximum amounts of the assistance au-
11	thorized, or set a limit on the number of partici-
12	pants, to ensure that amounts expended do not ex-
13	ceed available amounts.
14	"(c) Relation to Other Assistance.—Except as
15	provided in section $202(b)(1)(C)$ , a member of the District
16	of Columbia National Guard may receive financial assist-
17	ance under the program in addition to educational assist-
18	ance provided under any other provision of law.
19	"(d) Repayment.—A member of the District of Co-
20	lumbia National Guard who receives assistance under the
21	program and who, voluntarily or because of misconduct,
22	fails to serve for the period covered by the agreement re-
23	quired by section $202(b)(1)$ or fails to comply with the

24 eligibility conditions specified in section 202(b)(2) shall be

subject to the repayment provisions of section 373 of title
 37, United States Code.

### 3 "SEC. 204. ADMINISTRATION AND FUNDING OF PROGRAM.

4 "(a) Administration.—The Mayor, in coordination 5 with the commanding general of the District of Columbia National Guard and in consultation with approved institu-6 7 tions of higher education, shall develop policies and proce-8 dures for the administration of the program under this 9 title. Nothing in this title shall be construed to require 10 an institution of higher education to alter the institution's 11 admissions policies or standards in any manner to enable a member of the District of Columbia National Guard to 12 enroll in the institution. 13

14 "(b) FUNDING SOURCES AND GIFTS.—

15 "(1) AUTHORIZATION OF APPROPRIATIONS.— 16 There are authorized to be appropriated to the Dis-17 trict of Columbia such sums as may be necessary to 18 enable the Mayor to provide financial assistance 19 under the program. Funds appropriated pursuant to 20 this authorization of appropriations shall remain 21 available until expended.

"(2) TRANSFER OF FUNDS.—The Mayor may
accept the transfer of funds from Federal agencies
and use any funds so transferred for purposes of
providing assistance under the program. There is

authorized to be appropriated to the head of any ex ecutive branch agency such sums as may be nec essary to permit the transfer of funds to the Mayor
 to provide financial assistance under this section.

5 "(3) DONATIONS.—The Mayor may accept, use,
6 and dispose of donations of services or property for
7 purposes of providing assistance under the program.

### 8 "SEC. 205. DEFINITION.

9 "In this title, the term 'approved institution of higher
10 education' means an institution of higher education (as
11 defined in section 102 of the Higher Education Act of
12 1965 (20 U.S.C. 1002)) that—

"(1) is eligible to participate in the student financial assistance programs under title IV of the
Higher Education Act of 1965 (20 U.S.C. 1070 et
seq.); and

"(2) has entered into an agreement with the
Mayor containing an assurance that funds made
available under this title are used to supplement and
not supplant other assistance that may be available
for members of the District of Columbia National
Guard.

### **23 "SEC. 206. EFFECTIVE DATE.**

24 "Financial assistance may be provided under the pro-25 gram under this title to eligible members of the District

- 1 of Columbia National Guard for periods of instruction
- 2 that begin on or after January 1, 2020.".
