A BILL

To direct the Secretary of Energy to issue regulations regarding disclosure of oil data, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Know Your Oil Act".
- 5 SEC. 2. OIL DATA.
- 6 (a) REGULATIONS.—Not later than 1 year after the
- 7 date of the enactment of this Act, the Secretary of Energy
- 8 shall issue regulations to require companies that extract,
- 9 refine, or transport oil or transport refined products to
- 10 disclose field-level oil data, including—

| 9 | extraction, production, and refining; |
| 10 | (D) refinery processes and production |
| 11 | practices; |
| 12 | (E) supply chains, logistics, and methods |
| 13 | of transport for crude oil and refined products; |
| 14 | and |
| 15 | (F) production and reserve volumes of oil |
| 16 | fields; and |
| 17 | (3) standardized oil assays that are multi-cut |
| 18 | with fixed temperatures and routinely collected to |
| 19 | characterize each oil field resource. |
| 20 | (b) Consultation.—In carrying out this Act, the |
| 21 | Secretary shall consult with appropriate entities that are |
| 22 | authorized to collect relevant information, including— |
| 23 | (1) the Environmental Protection Agency; |
| 24 | (2) the Department of the Interior; |
| 25 | (3) the Securities and Exchange Commission; |

| 13 | (c) Reporting.—Not later than 1 year after the date |
| 14 | the Secretary issues regulations under subsection (a), the |
| 15 | Secretary shall publish and maintain thereafter the infor- |
| 16 | mation gathered pursuant to this Act online as an open |
| 17 | dataset. |
