Mr. CRIST (for himself and Mr. COHEN) introduced the following bill; which was referred to the Committee on Transportation and Infrastructure, and in addition to the Committees on Education and Labor, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To improve the safety of school buses, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Best to Use Safety
5 Belts Act of 2020” or the “BUS Act of 2020”.

6 **SEC. 2. SEAT BELT REQUIREMENT FOR SCHOOL BUSES.**

7 (a) REQUIREMENT.—Section 30125 of title 49,
8 United States Code, is amended by adding at the end the
9 following:

1 “(d) SEAT BELTS REQUIRED.—A person may not
2 manufacture for sale, sell, offer for sale, introduce or de-
3 liver for introduction in interstate commerce, or import
4 into the United States a schoolbus that is not equipped
5 with a seat belt that includes both lap and shoulder belts
6 for each intended passenger. A violation of this subsection
7 shall be treated as a violation of a motor vehicle safety
8 standard prescribed under section 30111 of this sub-
9 chapter.”.

10 (b) EFFECTIVE DATE.—The amendment made by
11 subsection (a) shall take effect 90 days after the date of
12 enactment of this Act.

13 **SEC. 3. SCHOOL BUS SAFETY UPGRADES GRANT PROGRAM.**

14 (a) ESTABLISHMENT.—Not later than 90 days after
15 the date of enactment of this Act, the Secretary of Trans-
16 portation shall establish a program to provide school buses
17 with seat belts and other safety features.

18 (b) GRANT AUTHORITY AND ELIGIBLE RECIPI-
19 ENTS.—In carrying out the program established under
20 subsection (a), the Secretary may make a grant, on a com-
21 petitive basis, to a State educational agency and a local
22 educational agency (as such terms are defined in section
23 8101 of the Elementary and Secondary Education Act of
24 1965 (20 U.S.C. 7801)).

1 (c) GRANT USES.—A recipient of a grant made under
2 subsection (b) may use grant funds only to—

3 (1) retrofit a school bus with seat belts; or

4 (2) make another safety upgrade to a school
5 bus that demonstrably decreases the risk of injury or
6 death to students in the event of an impact or roll-
7 over, including an upgrade designed to prevent a
8 rollover.

9 (d) AUTHORIZATION OF APPROPRIATIONS.—There is
10 authorized to be appropriated to carry out the program
11 established under subsection (a) \$3,000,000,000.

12 (e) TERMINATION.—The program established under
13 subsection (a) shall terminate on the date that is 2 years
14 after the date on which the program is established.
