# **A BILL**

To amend the Controlled Substances Act to authorize the debarment of certain registrants, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Debarment Enforcement*  
5       *of Bad Actor Registrants Act of 2020” or the “DEBAR Act*  
6       *of 2020”.*

7       **SEC. 2. DEBARMENT OF CERTAIN REGISTRANTS.**

8       *Section 304 of the Controlled Substances Act (21*  
9       *U.S.C. 824) is amended by adding at the end the following:*

10       *“(h) The Attorney General may issue an order to pro-*  
11       *hibit, conditionally or unconditionally, and permanently or*  
12       *for such period as the Attorney General may determine, any*  
13       *person from being registered under this title to manufac-*  
14       *ture, distribute, or dispense a controlled substance or a list*  
15       *I chemical, if the Attorney General finds that—*

16               *“(1) such person meets or has met any of the*  
17       *conditions for suspension or revocation of registration*  
18       *under subsection (a); and*

19               *“(2) such person has a history of prior suspen-*  
20       *sions or revocations of registration.”.*
