- 3 FOR the purpose of authorizing the Secretary of Labor, Licensing, and Regulation to 4 recover unemployment insurance benefits by assessment in the same manner as provided in a certain provision of law for the assessment of past due contributions; 5 requiring the Secretary, if the Secretary seeks to recover certain unemployment 6 7 benefits by assessment, to allow a claimant to elect within a certain period of time to 8 have the amount collected by suit instead of by assessment; requiring the Secretary 9 to adopt certain regulations; and generally relating to the recovery of unemployment insurance benefits by assessment. 10
