A BILL

- To amend title 18, United States Code, to provide a means by which nonresidents of a State whose residents may carry concealed firearms may also do so in the State.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Concealed Carry Reci-
 - 5 procity Act".
 - 6 SEC. 2. RECIPROCITY FOR THE CARRYING OF CERTAIN
 - 7 CONCEALED FIREARMS.
 - 8 (a) In General.—Chapter 44 of title 18, United
 - 9 States Code, is amended by inserting after section 926C
- 10 the following:
- 11 "§ 926D. Reciprocity for the carrying of certain con-
- 12 cealed firearms
- 13 "(a) Notwithstanding any provision of the law of any
- 14 State or political subdivision thereof (except as provided
- 15 in subsection (b)) and subject only to the requirements
- 16 of this section, a person who is not prohibited by Federal
- 17 law from possessing, transporting, shipping, or receiving
- 18 a firearm, who is carrying a valid identification document
- 19 containing a photograph of the person, and who is car-
- 20 rying a valid license or permit which is issued pursuant
- 21 to the law of a State and which permits the person to

- 1 carry a concealed firearm or is entitled to carry a con-
- 2 cealed firearm in the State in which the person resides,
- 3 may possess or carry a concealed handgun (other than a
- 4 machine gun or destructive device) that has been shipped
- 5 or transported in interstate or foreign commerce, in any
- 6 State that—
- 7 "(1) has a statute under which residents of the
- 8 State may apply for a license or permit to carry a
- 9 concealed firearm; or
- 10 "(2) does not prohibit the carrying of concealed
- firearms by residents of the State for lawful pur-
- poses.
- 13 "(b) This section shall not be construed to supersede
- 14 or limit the laws of any State that—
- 15 "(1) permit private persons or entities to pro-
- hibit or restrict the possession of concealed firearms
- on their property; or
- 18 "(2) prohibit or restrict the possession of fire-
- arms on any State or local government property, in-
- stallation, building, base, or park.
- 21 "(c)(1) A person who carries or possesses a concealed
- 22 handgun in accordance with subsections (a) and (b) may
- 23 not be arrested or otherwise detained for violation of any
- 24 law or any rule or regulation of a State or any political
- 25 subdivision thereof related to the possession, transpor-

- 1 tation, or carrying of firearms unless there is probable
- 2 cause to believe that the person is doing so in a manner
- 3 not provided for by this section. Presentation of facially
- 4 valid documents as specified in subsection (a) is prima
- 5 facie evidence that the individual has a license or permit
- 6 as required by this section.
- 7 "(2) When a person asserts this section as a defense
- 8 in a criminal proceeding, the prosecution shall bear the
- 9 burden of proving, beyond a reasonable doubt, that the
- 10 conduct of the person did not satisfy the conditions set
- 11 forth in subsections (a) and (b).
- 12 "(3) When a person successfully asserts this section
- 13 as a defense in a criminal proceeding, the court shall
- 14 award the prevailing defendant a reasonable attorney's
- 15 fee.
- 16 "(d)(1) A person who is deprived of any right, privi-
- 17 lege, or immunity secured by this section, under color of
- 18 any statute, ordinance, regulation, custom, or usage of any
- 19 State or any political subdivision thereof, may bring an
- 20 action in any appropriate court against any other person,
- 21 including a State or political subdivision thereof, who
- 22 causes the person to be subject to the deprivation, for
- 23 damages or other appropriate relief.
- 24 "(2) The court shall award a plaintiff prevailing in
- 25 an action brought under paragraph (1) damages and such

- 1 other relief as the court deems appropriate, including a
- 2 reasonable attorney's fee.
- 3 "(e) In subsection (a):
- 4 "(1) The term 'identification document' means
- 5 a document made or issued by or under the author-
- 6 ity of the United States Government, a State, or a
- 7 political subdivision of a State which, when com-
- 8 pleted with information concerning a particular indi-
- 9 vidual, is of a type intended or commonly accepted
- for the purpose of identification of individuals.
- 11 "(2) The term 'handgun' includes any magazine
- for use in a handgun and any ammunition loaded
- into the handgun or its magazine.
- 14 "(f)(1) A person who possesses or carries a concealed
- 15 handgun under subsection (a) shall not be subject to the
- 16 prohibitions of section 922(q) with respect to that hand-
- 17 gun.
- 18 "(2) A person possessing or carrying a concealed
- 19 handgun in a State under subsection (a) may do so in
- 20 any of the following areas in the State that are open to
- 21 the public:
- 22 "(A) A unit of the National Park System.
- 23 "(B) A unit of the National Wildlife Refuge
- 24 System.

- 1 "(C) Public land under the jurisdiction of the
- 2 Bureau of Land Management.
- 3 "(D) Land administered and managed by the
- 4 Army Corps of Engineers.
- 5 "(E) Land administered and managed by the
- 6 Bureau of Reclamation.
- 7 "(F) Land administered and managed by the
- 8 Forest Service.".
- 9 (b) CLERICAL AMENDMENT.—The table of sections
- 10 for such chapter is amended by inserting after the item
- 11 relating to section 926C the following:
 - "926D. Reciprocity for the carrying of certain concealed firearms.".
- 12 (c) Severability.—Notwithstanding any other pro-
- 13 vision of this Act, if any provision of this section, or any
- 14 amendment made by this section, or the application of
- 15 such provision or amendment to any person or circum-
- 16 stance is held to be unconstitutional, this section and
- 17 amendments made by this section and the application of
- 18 such provision or amendment to other persons or cir-
- 19 cumstances shall not be affected thereby.
- 20 (d) Effective Date.—The amendments made by
- 21 this section shall take effect 90 days after the date of the
- 22 enactment of this Act.
