### AN ACT

To amend title 38, United States Code, to provide for a bar on the recovery of certain payments or overpayments made by the Department of Veterans Affairs by reason of delays in processing of certain information, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Stopping Harm and
- 5 Implementing Enhanced Lead-time for Debts for Veterans
- 6 Act" or the "SHIELD for Veterans Act".

| 10 | "(a) Limitation.—No individual may incur a debt              |
| 11 | to the United States that—                                   |
| 12 | "(1) arises from any program or benefit admin-               |
| 13 | istered by the Under Secretary for Benefits; and             |
| 14 | "(2) is attributable to the failure of an em-                |
| 15 | ployee or official of the Department to process infor-       |
| 16 | mation provided by or on behalf of that individual           |
| 17 | within applicable timeliness standards established by        |
| 18 | the Secretary.   |
| 19 | "(b) NOTICE TO BENEFICIARY.—If the Secretary de-             |
| 20 | termines that the Secretary has made an overpayment to       |
| 21 | an individual, the Secretary shall provide notice to the in- |
| 22 | dividual of the overpayment. Such notice shall include an    |
| 23 | explanation of the right of the individual to dispute the    |
| 24 | overpayment or to request a waiver of indebtedness.          |
| 25 | "(c) Delay on Collection.—The Secretary may                  |

| 8  | (3) DEADLINE.—The Secretary of Veterans Af-  |

| 14 | MUNICATION OF DEBTS.—Not later than 180 days after                                 |

  - (B) The development and implementation of a mechanism by which individuals eligible for benefits under the laws administered by the Secretary may receive electronic correspondence relating to debt and overpayment information.
  - (C) The development and implementation, by not later than October 1, 2022, of a mechanism by which individuals eligible for benefits under the laws administered by the Secretary may access information related to Department of Veterans Affairs debt electronically.
  - (D) The improvement and clarification of Department communications relating to over-payments and debt collection, including letters and electronic correspondence. The Secretary shall develop such improvements and clarifications in consultation with veterans service organizations and other relevant non-governmental organizations.
  - (E) The development and implementation, by not later than October 1, 2022, of a mecha-

- nism by which veterans may update their dependency information electronically.
- 3 (2) A description of the current efforts and 4 plans for improving the accuracy of payments to in-5 dividuals entitled to benefits under the laws adminis-6 tered by the Secretary, including specific data 7 matching agreements.
  - (3) A description of steps to be taken to improve the identification of underpayments to such individuals and to improve Department procedures and policies to ensure that such individuals who are underpaid receive adequate compensation payments.
- 13 (4) A list of actions completed, implementation 14 steps, and timetables for each requirement described 15 in paragraphs (1) through (3).
- 16 (5) A description of any new legislative author-17 ity required to complete any such requirement.
- 18 SEC. 3. THRESHOLD FOR REPORTING DEBTS TO CON-19 SUMER REPORTING AGENCIES.
- 20 (a) IN GENERAL.—Chapter 53 of title 38, United 21 States Code, is amended by adding after section 5319 the 22 following new section:

| 18 | PENSATION OR PENSION.  |
| 19 | The Secretary of Veterans Affairs shall ensure that—                   |
| 20 | (1) a veteran may remove any dependent from                            |
| 21 | an award of compensation or pension to the veteran                     |
| 22 | using the eBenefits system of the Department of                        |
| 23 | Veterans Affairs, or a successor system; and                           |

- 1 (2) such removal takes effect not later than 60
- 2 days after the date on which the veteran makes such
- 3 removal.

### 4 SEC. 5. DETERMINATION OF BUDGETARY EFFECTS.

- 5 The budgetary effects of this Act, for the purpose of
- 6 complying with the Statutory Pay-As-You-Go Act of 2010,
- 7 shall be determined by reference to the latest statement
- 8 titled "Budgetary Effects of PAYGO Legislation" for this
- 9 Act, submitted for printing in the Congressional Record
- 10 by the Chairman of the House Budget Committee, pro-
- 11 vided that such statement has been submitted prior to the
- 12 vote on passage.
