A BILL

To exempt from the calculation of monthly income certain benefits paid by the Department of Veterans Affairs and the Department of Defense.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Honoring American
5 Veterans in Extreme Need Act of 2019” or the “HAVEN
6 Act”.

7 **SEC. 2. DEFINITION OF CURRENT MONTHLY INCOME.**

8 Section 101(10A) of title 11, United States Code, is
9 amended by striking subparagraph (B) and inserting the
10 following:

11 “(B)(i) includes any amount paid by any
12 entity other than the debtor (or in a joint case
13 the debtor and the debtor’s spouse), on a reg-
14 ular basis for the household expenses of the
15 debtor or the debtor’s dependents (and in a
16 joint case the debtor’s spouse if not otherwise
17 a dependent); and

18 “(ii) excludes—

19 “(I) benefits received under the Social
20 Security Act (42 U.S.C. 301 et seq.);

21 “(II) payments to victims of war
22 crimes or crimes against humanity on ac-
23 count of their status as victims of such
24 crimes;

1 “(III) payments to victims of inter-
2 national terrorism or domestic terrorism,
3 as those terms are defined in section 2331
4 of title 18, on account of their status as
5 victims of such terrorism; and

6 “(IV) any monthly compensation, pen-
7 sion, pay, annuity, or allowance paid under
8 title 10, 37, or 38 in connection with a dis-
9 ability, combat-related injury or disability,
10 or death of a member of the uniformed
11 services, except that any retired pay ex-
12 cluded under this subclause shall include
13 retired pay paid under chapter 61 of title
14 10 only to the extent that such retired pay
15 exceeds the amount of retired pay to which
16 the debtor would otherwise be entitled if
17 retired under any provision of title 10
18 other than chapter 61 of that title.”.
