10 (2) The terms of the members are staggered as required by the terms 11 provided for members of the State Advisory Board on October 1, 2007.

12 (3) At the end of a term, a member continues to serve until a successor is 13 appointed and qualifies.

14 (4) A member who is appointed after a term has begun serves only for the 15 rest of the term and until a successor is appointed and qualifies.

16 (5) A member who serves two consecutive full 3-year terms may not be 17 reappointed for 3 years after completion of those terms.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 October 1, 2020.
