A BILL

To require individuals fishing for Gulf reef fish to use certain descending devices, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Direct Enhancement of
- 5 Snapper Conservation and the Economy through Novel De-
- 6 vices Act of 2020" or the "DESCEND Act of 2020".

7 SEC. 2. SENSE OF CONGRESS.

- 8 It is the sense of Congress that commercial and rec-
- 9 reational fishermen (which, for the purpose of this Act shall
- 10 include charter fishing) for Gulf reef fish are expected to
- 11 use a venting tool or a descending device required for posses-
- 12 sion under section 3 when releasing fish that are exhibiting
- 13 signs of barotrauma. The Secretary of Commerce (referred
- 14 to in this Act as the "Secretary"), in coordination with the
- 15 Gulf of Mexico Fishery Management Council, should de-
- 16 velop and disseminate to fishermen education and outreach
- 17 materials related to proper use of venting tools and descend-
- 18 ing devices, and strongly encourage their use by commercial
- 19 and recreational fishermen when releasing fish that are ex-
- $20 \ \ hibiting \ signs \ of \ barotrauma.$

21 SEC. 3. REQUIRED POSSESSION OF DESCENDING DEVICES.
