## A BILL

To amend the Uyghur Human Rights Policy Act of 2020 to impose additional sanctions relating to human rights abuses in the Xinjiang Uyghur Autonomous Region.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Sanctioning Sup-  
3 porters of Slave Labor Act”.

4 **SEC. 2. IMPOSITION OF ADDITIONAL SANCTIONS RELATING**  
5 **TO HUMAN RIGHTS ABUSES IN THE XINJIANG**  
6 **UYGHUR AUTONOMOUS REGION.**

7 (a) IN GENERAL.—Section 6 of the Uyghur Human  
8 Rights Policy Act of 2020 (Public Law 116–145; 22  
9 U.S.C. 6901 note) is amended—

10 (1) in subsection (a)—

11 (A) by redesignating paragraph (2) as  
12 paragraph (3); and

13 (B) by inserting after paragraph (1) the  
14 following:

15 “(2) ADDITIONAL MATTERS TO BE IN-  
16 CLUDED.—The President shall include in the report  
17 required by paragraph (1) an identification of—

18 “(A) each foreign person that knowingly  
19 provides material support to or for a person  
20 identified in such report; and

21 “(B) each foreign person that knowingly  
22 engages in a significant transaction relating to  
23 any of the acts described in subparagraphs (A)  
24 through (F) of paragraph (1).”; and

25 (2) in subsection (b), by striking “subsection  
26 (a)(1)” and inserting “subsection (a)”.

1 (b) EFFECTIVE DATE.—The amendments made by  
2 subsection (a)—

3 (1) take effect on the date of the enactment of  
4 this Act; and

5 (2) apply with respect to each report required  
6 by section 6(a) of the Uyghur Human Rights Policy  
7 Act of 2020 submitted before, on, or after such date  
8 of enactment.
