## A BILL

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to establish the Adverse Childhood Experiences Response Team grant program, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. ADVERSE CHILDHOOD EXPERIENCES RE-4 SPONSE TEAM GRANT PROGRAM.

5 (a) IN GENERAL.—Title I of the Omnibus Crime
6 Control and Safe Streets Act of 1968 (34 U.S.C. 10101
7 et seq.) is amended by adding at the end the following:

1	<b>"PART OO—ADVERSE CHILDHOOD EXPERIENCES</b>
2	<b>RESPONSE TEAM GRANT PROGRAM</b>
3	"SEC. 3051. GRANTS FOR ADVERSE CHILDHOOD EXPERI-
4	ENCES RESPONSE TEAMS.

5 "(a) GRANTS AUTHORIZED.—From amounts made 6 available to carry out this section, the Attorney General, 7 in coordination with the Secretary of Health and Human 8 Services, shall make grants to States, units of local gov-9 ernment, Indian Tribes, and neighborhood or community-10 based organizations to address adverse childhood experi-11 ences associated with exposure to trauma.

12 "(b) USE OF FUNDS.—Amounts received under a
13 grant under this section may be used to establish an ad14 verse childhood experiences response team, including by—
15 "(1) establishing protocols to follow when en16 countering a child or youth exposed to trauma to fa17 cilitate access to services;

18 "(2) developing referral partnership agreements
19 with behavioral health providers, substance treat20 ment facilities, and recovery services for family
21 members of children exposed to trauma;

"(3) integrating law enforcement, mental
health, and crisis services to respond to situations
where children have been exposed to trauma;

25 "(4) implementing comprehensive programs and
26 practices to support children exposed to trauma;

"(5) identifying barriers for children to access
 trauma-informed care in their communities;

3 "(6) providing training in trauma-informed care
4 to emergency response providers, victim service pro5 viders, child protective service professionals, edu6 cational institutions, and other community partners;
7 and

8 "(7) supporting cross-system planning and col-9 laboration among officers and employees who work 10 in law enforcement, court systems, child welfare 11 services, correctional reentry programs, emergency 12 medical services, health care services, public health, 13 and substance abuse treatment and recovery sup-14 port.

15 "(c) APPLICATION.—A State, unit of local govern-16 ment, Indian Tribe, or neighborhood or community-based 17 organization desiring a grant under this section shall sub-18 mit to the Attorney General an application in such form, 19 and containing such information, as the Attorney General 20 may reasonably require.".

(b) AUTHORIZATION OF APPROPRIATIONS.—Section
1001(a) of title I of the Omnibus Crime Control and Safe
Streets Act of 1968 (34 U.S.C. 10261(a)) is amended by
adding at the end the following:

"(29) There are authorized to be appropriated to
 carry out part OO \$10,000,000 for each of fiscal years
 2020 through 2023.".
