1 Homecoming queen and spending a semester abroad in Managua, Nicaragua; and 2 WHEREAS, Bria currently works as an intern with CenturyLink, a global 3 communications hosting cloud and IT services company on the Fortune 500 list of America's 4 largest corporations, and between school and work she also volunteers with the local United Way chapter every Wednesday through the "Read. Learn.
