Mr. CASEY (for himself, Mr. BOOKER, and Mr. REED) introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To provide for special enrollment periods during public health emergencies, coverage of services related to public health emergencies, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ensuring Coverage in
5 Public Health Emergencies Act of 2020”.

1 **SEC. 2. SPECIAL ENROLLMENT PERIODS DURING PUBLIC**
 2 **HEALTH EMERGENCIES.**

3 (a) PUBLIC HEALTH SERVICE ACT.—Title XXVII of
 4 the Public Health Service Act (42 U.S.C. 300gg et seq.)
 5 is amended—

6 (1) in section 2702(b)(2) (42 U.S.C. 300gg–
 7 1(b)(2)), by inserting “, which shall include a special
 8 enrollment period of 30 days during a public health
 9 emergency declared under section 319, which period
 10 may be extended for such time as the Secretary may
 11 require” before the period at the end; and

12 (2) in section 2704(f) (42 U.S.C. 300gg–3(f)),
 13 by adding at the end the following:

14 “(4) PUBLIC HEALTH EMERGENCIES.—If the
 15 Secretary declares a public health emergency under
 16 section 319, group health plan, and a group health
 17 insurance issuer offering group health insurance cov-
 18 erage in connection with a group health plan, shall
 19 permit an employee who is eligible, but not enrolled,
 20 for coverage under the terms of the plan or coverage
 21 (or a dependent of such an employee if the depend-
 22 ent is eligible, but not enrolled, for coverage under
 23 such terms) to enroll for coverage under the terms
 24 of the plan or coverage during the special enrollment
 25 period required under section 2702(b)(2) of the Pub-
 26 lic Health Service Act (42 U.S.C. 300gg–1(b)(2)).”.

1 (b) ERISA.—Section 701(f) of the Employee Retire-
2 ment Income Security Act of 1974 (29 U.S.C. 1181(f))
3 is amended by adding at the end the following:

4 “(4) PUBLIC HEALTH EMERGENCIES.—If the
5 Secretary of Health and Human Services declares a
6 public health emergency under section 319 of the
7 Public Health Service Act (42 U.S.C. 247d), a
8 group health plan, or a health insurance issuer offer-
9 ing group health insurance coverage in connection
10 with such a plan, shall permit an employee who is
11 eligible, but not enrolled, for coverage under the
12 terms of the plan or coverage (or a dependent of
13 such an employee if the dependent is eligible, but
14 not enrolled, for coverage under such terms) to en-
15 roll for coverage under the terms of the plan or cov-
16 erage during the special enrollment period required
17 under section 2702(b)(2) of the Public Health Serv-
18 ice Act (42 U.S.C. 300gg–1(b)(2)).”.

19 (c) IRC.—Section 9801(f) of the Internal Revenue
20 Code of 1986 (26 U.S.C. 9801(f)) is amended by adding
21 at the end the following new paragraph:

22 “(4) PUBLIC HEALTH EMERGENCIES.—If the
23 Secretary of Health and Human Services declares a
24 public health emergency under section 319 of the
25 Public Health Service Act (42 U.S.C. 247d), a

1 group health plan shall permit an employee who is
 2 eligible, but not enrolled, for coverage under the
 3 terms of the plan (or a dependent of such an em-
 4 ployee if the dependent is eligible, but not enrolled,
 5 for coverage under such terms) to enroll for coverage
 6 under the terms of the plan during the special en-
 7 rollment period required under section 2702(b)(2) of
 8 the Public Health Service Act (42 U.S.C. 300gg–
 9 1(b)(2)).”.

10 (d) RULE OF CONSTRUCTION.—Nothing in the
 11 amendments made by subsections (a) and (b) shall be con-
 12 strued to prevent group health plan or health insurance
 13 issuer from offering a special enrollment period in addition
 14 to any such period required under Federal law.

15 **SEC. 3. COVERAGE OF PREVENTION AND TREATMENT RE-**
 16 **LATED TO PUBLIC HEALTH EMERGENCIES.**

17 (a) REQUIRED COVERAGE.—

18 (1) IN GENERAL.—Subpart II of part A of title
 19 XXVII of the Public Health Service Act (42 U.S.C.
 20 300gg–11 et seq.) is amended by adding at the end
 21 the following:

22 **“SEC. 2729A. COVERAGE OF PREVENTION AND TREATMENT**
 23 **RELATED TO PUBLIC HEALTH EMERGENCIES.**

24 “(a) IN GENERAL.—A group health plan or a health
 25 insurance issuer offering group or individual health insur-

1 ance coverage shall provide coverage for such services re-
 2 lated to a disease or condition relating to a public health
 3 emergency declared under section 319, which, as applica-
 4 ble, shall include any services for the prevention or treat-
 5 ment, of the disease or condition.

6 “(b) SCOPE OF BENEFITS.—The prevention and
 7 treatment measures for which coverage is required under
 8 subsection (a) shall—

9 “(1) be at the same level as benefits for the
 10 prevention or treatment of other similar or related
 11 diseases or conditions, if applicable, under the plan
 12 or coverage; and

13 “(2) include, with respect to the disease or con-
 14 dition reasonably related to the public health emer-
 15 gency, even if no diagnosis has been made and even
 16 if the enrollee ultimately is determined not to have
 17 the disease or condition, as applicable—

18 “(A) vaccines to prevent the disease or
 19 condition, if applicable;

20 “(B) testing for diagnosis of the disease or
 21 condition, if applicable;

22 “(C) care related to symptoms an enrollee
 23 may experience; and

24 “(D) treatments for the disease or condi-
 25 tion.

1 “(c) COST-SHARING.—Cost-sharing for services for
 2 which coverage is required under subsection (a) shall be
 3 comparable to similar such services that would be covered
 4 by the plan or coverage outside of a public health emer-
 5 gency.

6 “(d) WAIVER OF RESTRICTIONS.—

7 “(1) IN GENERAL.—A group health plan or
 8 health insurance issuer offering group or individual
 9 health insurance coverage shall waive any restriction
 10 (including any prior authorization requirement, limi-
 11 tation on filling or refilling prescription drugs, or
 12 other restrictions) on access to covered benefits re-
 13 quired under this section, if the service is deter-
 14 mined by a qualified health professional to be medi-
 15 cally necessary by the provider and the Secretary de-
 16 termines such restriction to be unduly burdensome
 17 in the context of the applicable public health emer-
 18 gency.

19 “(2) TERM OF WAIVER.—Any waiver of restric-
 20 tions pursuant to paragraph (1) shall apply only for
 21 the duration of the public health emergency, as de-
 22 clared under section 319.”.

23 (2) ERISA.—

24 (A) IN GENERAL.—Subpart B of part 7 of
 25 subtitle B of title I of the Employee Retirement

1 Income Security Act of 1974 (29 U.S.C. 1181
2 et. seq.) is amended by adding at the end the
3 following:

4 **“SEC. 716. COVERAGE OF PREVENTION AND TREATMENT**
5 **RELATED TO PUBLIC HEALTH EMERGENCIES.**

6 “(a) IN GENERAL.—A group health plan or a health
7 insurance issuer offering group health insurance coverage,
8 shall provide coverage for such services related to a disease
9 or condition relating to a public health emergency declared
10 under section 319 of the Public Health Service Act, which,
11 as applicable, shall include any services for the prevention
12 or treatment, of the disease or condition.

13 “(b) SCOPE OF BENEFITS.—The prevention and
14 treatment measures for which coverage is required under
15 subsection (a) shall—

16 “(1) be at the same level as benefits for the
17 prevention or treatment of other similar or related
18 diseases or conditions, if applicable, under the plan
19 or coverage; and

20 “(2) include, with respect to the disease or con-
21 dition reasonably related to the public health emer-
22 gency, even if no diagnosis has been made and even
23 if the enrollee ultimately is determined not to have
24 the disease or condition, as applicable—

1 “(A) vaccines to prevent the disease or
2 condition, if applicable;

3 “(B) testing for diagnosis of the disease or
4 condition, if applicable;

5 “(C) care related to symptoms an enrollee
6 may experience; and

7 “(D) treatments for the disease or condi-
8 tion.

9 “(c) COST-SHARING.—Cost-sharing for services for
10 which coverage is required under subsection (a) shall be
11 comparable to similar such services that would be covered
12 by the plan or coverage outside of a public health emer-
13 gency.

14 “(d) WAIVER OF RESTRICTIONS.—

15 “(1) IN GENERAL.—A group health plan or
16 health insurance issuer offering group health insur-
17 ance coverage shall waive any restriction (including
18 any prior authorization requirement, limitation on
19 filling or refilling prescription drugs, or other re-
20 strictions) on access to covered benefits required
21 under this section, if the service is determined by a
22 qualified health professional to be medically nec-
23 essary by the provider and the Secretary determines
24 such restriction to be unduly burdensome in the con-
25 text of the applicable public health emergency.

1 “(2) TERM OF WAIVER.—Any waiver of restric-
 2 tions pursuant to paragraph (1) shall apply only for
 3 the duration of the public health emergency, as de-
 4 clared under section 319 of the Public Health Serv-
 5 ice Act.”.

6 (B) CLERICAL AMENDMENT.—The table of
 7 sections for subpart B of part 7 of subtitle B
 8 of title I of the Employee Retirement Income
 9 Security Act of 1974 is amended by adding at
 10 the end the following:

“Sec. 715. Additional market reforms.

“Sec. 716. Coverage of prevention and treatment related to public health emer-
 gencies.”.

11 (3) IRC.—

12 (A) IN GENERAL.—Subchapter B of chap-
 13 ter 100 of the Internal Revenue Code of 1986
 14 is amended by adding at the end the following
 15 new section:

16 **“SEC. 9816. COVERAGE OF PREVENTION AND TREATMENT**
 17 **RELATED TO PUBLIC HEALTH EMERGENCIES.**

18 “(a) IN GENERAL.—A group health plan shall pro-
 19 vide coverage for such services related to a disease or con-
 20 dition relating to a public health emergency declared
 21 under section 319 of the Public Health Service Act, which,
 22 as applicable, shall include any services for the prevention
 23 or treatment, of the disease or condition.

1 “(b) SCOPE OF BENEFITS.—The prevention and
2 treatment measures for which coverage is required under
3 subsection (a) shall—

4 “(1) be at the same level as benefits for the
5 prevention or treatment of other similar or related
6 diseases or conditions, if applicable, under the plan;
7 and

8 “(2) include, with respect to the disease or con-
9 dition reasonably related to the public health emer-
10 gency, even if no diagnosis has been made and even
11 if the enrollee ultimately is determined not to have
12 the disease or condition, as applicable—

13 “(A) vaccines to prevent the disease or
14 condition, if applicable;

15 “(B) testing for diagnosis of the disease or
16 condition, if applicable;

17 “(C) care related to symptoms an enrollee
18 may experience; and

19 “(D) treatments for the disease or condi-
20 tion.

21 “(c) COST-SHARING.—Cost-sharing for services for
22 which coverage is required under subsection (a) shall be
23 comparable to similar such services that would be covered
24 by the plan outside of a public health emergency.

25 “(d) WAIVER OF RESTRICTIONS.—

1 “(1) IN GENERAL.—A group health plan shall
 2 waive any restriction (including any prior authoriza-
 3 tion requirement, limitation on filling or refilling
 4 prescription drugs, or other restrictions) on access to
 5 covered benefits required under this section, if the
 6 service is determined by a qualified health profes-
 7 sional to be medically necessary by the provider and
 8 the Secretary determines such restriction to be un-
 9 duly burdensome in the context of the applicable
 10 public health emergency.

11 “(2) TERM OF WAIVER.—Any waiver of restric-
 12 tions pursuant to paragraph (1) shall apply only for
 13 the duration of the public health emergency, as de-
 14 clared under section 319 of the Public Health Serv-
 15 ice Act.”.

16 (B) CLERICAL AMENDMENT.—The table of
 17 sections for subchapter B of chapter 100 of
 18 such Code is amended by adding at the end the
 19 following new item:

“Sec. 9816. Coverage of prevention and treatment related to public health
 emergencies.”.

20 **SEC. 4. EFFECTIVE DATE; APPLICATION.**

21 The amendments made by this Act shall take effect
 22 on the date of enactment of this Act and shall apply with
 23 respect to plans years in effect on the date of enactment

1 of this Act, and plan years beginning on or after such
2 date.
