## A BILL

To require Federal agencies to submit plans for responding to any resurgence of COVID-19, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

### **3 SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "COVID Preparedness,

5 Response, and Effective Planning for Advanced Require6 ments by the Executive Branch Act" or the "COVID
7 PREPARE Act".

#### 1 SEC. 2. COVID-19 RESURGENCE PLAN.

2 (a) IN GENERAL.—Not later than 30 days after the 3 date of the enactment of this Act, the head of each agency 4 shall submit to Congress an initial report detailing an ac-5 tion plan, informed by research and best practices learned from the onset of COVID–19 and previous presidentially 6 7 declared emergencies, for addressing the needs and miti-8 gating and eliminating the risks and challenges associated 9 with any resurgence in COVID-19 cases, that includes— 10 (1) agency priorities for preparing for and re-11 sponding to any resurgence of COVID-19, including 12 continuity of operations and fulfilling the mission of 13 the agency; 14 (2) measurable goals specific to priorities and a 15 time line for addressing each priority; 16 (3) anticipated challenges to addressing prior-17 ities and how the agency will address such chal-18 lenges; 19 (4) how the agency will consult with Congress, 20 the public, State and municipal governments, and 21 relevant stakeholders while working remotely; and 22 (5) how the agency plans to issue relevant guid-23 ance to entities under the jurisdiction of the agency. 24 (b) SUBSEQUENT REPORTS.—Not later than 60 days 25 after the date of the enactment of this Act, and guarterly

26 thereafter until the President ends the declared emer-

1	gency, the head of each agency shall submit to Congress
2	a report that provides an update of the details submitted
3	in the plan under subsection (a), including—
4	(1) the status of each priority;
5	(2) an explanation for any goal that has not
6	been met within the specified time frame; and
7	(3) any changes or updates to the plan.
8	(c) DEFINITIONS.—In this section:
9	(1) AGENCY.—The term "agency" has the
10	meaning given that term in section 551 of title 5,
11	United States Code.
12	(2) STATE.—The term "State" means each of
13	the several States, the District of Columbia, each
14	commonwealth, territory, or possession of the United
15	States, and each federally recognized Indian Tribe.
