A BILL

To direct the Secretary of Veterans Affairs to conduct and support research on the efficacy and safety of medicinal cannabis, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Cannabis
- 5 Analysis, Research, and Effectiveness Act" or the "Vet-
- 6 erans CARE Act".

1	SEC. 2. CONDUCT OF RESEARCH INTO EFFECTS OF CAN-
2	NABIS ON HEALTH OUTCOMES OF CERTAIN
3	VETERANS.
4	(a) Research.—In carrying out the responsibilities
5	of the Secretary of Veterans Affairs under section 7303
6	of title 38, United States Code, the Secretary shall con-
7	duct and support research relating to the efficacy and
8	safety of forms of cannabis described in subsection (c) on
9	the health outcomes of covered veterans diagnosed with
10	chronic pain, post-traumatic stress disorder, and other
11	conditions the Secretary determines appropriate. The Sec-
12	retary shall ensure that such research is conducted in ac-
13	cordance with applicable regulations relating to the over-
14	sight of research, including such regulations prescribed by
15	the Office of Research and Development of the Depart-
16	ment of Veterans Affairs, the Department of Health and
17	Human Services (including through the National Institute
18	on Drug Abuse), the Food and Drug Administration, the
19	Drug Enforcement Administration, and the National In-
20	stitutes of Health.
21	(b) Data Preservation.—Research conducted pur-
22	suant to subsection (a) shall include a mechanism to en-

suant to subsection (a) shall include a mechanism to ensure the preservation of all data, including all data sets, collected or used for purposes of the research required by subsection (a) in a manner that will facilitate further research.

1	(c) FORMS OF CANNABIS TO BE RESEARCHED.—The
2	forms of cannabis described in this subsection are—
3	(1) varying forms of cannabis, including—
4	(A) full plants and extracts;
5	(B) at least three different strains of can-
6	nabis with significant variants in phenotypic
7	traits and various ratios of
8	tetrahydrocannabinol and cannabidiol in chem-
9	ical composition; and
10	(C) other chemical analogs of
11	tetrahydrocannabinol; and
12	(2) varying methods of cannabis delivery, in-
13	cluding topical application, combustible and non-
14	combustible inhalation, and ingestion.
15	(d) Implementation.—In conducting and sup-
16	porting research under subsection (a), the Secretary
17	shall—
18	(1) before conducting and supporting such re-
19	search, develop a plan to implement this section and
20	submit such plan to the Committees on Veterans'
21	Affairs of the House of Representatives and the Sen-
22	ate; and
23	(2) issue any requests for proposals the Sec-
24	retary determines appropriate for such implementa-
25	tion.

- 1 (e) Reports.—During the five-year period beginning
- 2 on the date of the enactment of this Act, the Secretary
- 3 shall submit periodically, but not less frequently than an-
- 4 nually, to the Committees on Veterans' Affairs of the
- 5 House of Representatives and the Senate reports on the
- 6 implementation of this section.
- 7 (f) Covered Veteran Defined.—In this section,
- 8 the term "covered veteran" means a veteran who is en-
- 9 rolled in the patient enrollment system of the Department
- 10 of Veterans Affairs under section 1705 of title 38, United
- 11 States Code.
