AN ACT

To extend the trade adjustment assistance program for one month.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Trade Adjustment As-
3 sistance Extension Act of 2021”.

4 **SEC. 2. EXTENSION OF TRADE ADJUSTMENT ASSISTANCE**
5 **PROGRAM.**

6 (a) **EXTENSION OF TERMINATION PROVISIONS.**—
7 Section 285 of the Trade Act of 1974 (19 U.S.C. 2271
8 note) is amended by striking “June 30, 2021” each place
9 it appears and inserting “July 23, 2021”.

10 (b) **REEMPLOYMENT TRADE ADJUSTMENT ASSIST-**
11 **ANCE.**—Section 246(b)(1) of the Trade Act of 1974 (19
12 U.S.C. 2318(b)(1)) is amended by striking “June 30,
13 2021” and inserting “July 23, 2021”.

14 (c) **TRADE ADJUSTMENT ASSISTANCE FOR WORK-**
15 **ERS.**—Section 245(a) of the Trade Act of 1974 (19 U.S.C.
16 2317(a)) is amended by striking “June 30, 2021” and in-
17 serting “July 23, 2021”.

18 (d) **EFFECTIVE DATE.**—The amendments made by
19 this section take effect on the earlier of—

- 20 (1) the date of the enactment of this Act; or
21 (2) June 30, 2021.

22 (e) **APPLICATION OF PRIOR LAW.**—Section 406 of
23 the Trade Adjustment Assistance Reauthorization Act of
24 2015 (title IV of Public Law 114–27; 129 Stat. 379; 19
25 U.S.C. 2271 note prec.) is amended—

- 26 (1) in subsection (a)—

1 (A) in the matter preceding paragraph (1),
2 by striking “July 1, 2021” and inserting “July
3 24, 2021”; and

4 (B) in paragraphs (5) and (6), by striking
5 “the 1-year period beginning on July 1, 2021”
6 and inserting “the period beginning on July 24,
7 2021, and ending on June 30, 2022”; and

8 (2) in subsection (b), by striking “July 1,
9 2021” each place it appears and inserting “July 24,
10 2021”.
