- 3 FOR the purpose of establishing the Interjurisdictional Policing Grant Program to provide 4 counties with grants to defray costs associated with establishing and supporting interjurisdictional policing agreements; requiring the Governor, in each fiscal year, 5 6 to provide a certain amount of funding in the annual budget bill; requiring the 7 Executive Director of the Governor's Office of Crime Control and Prevention to 8 administer the Program and establish certain requirements for the Program; 9 specifying certain details regarding application procedures and grant awards under 10 the Program; requiring a grantee to submit a certain report and the Executive 11 Director to post that report to a certain website; defining certain terms; and generally 12 relating to the Interjurisdictional Policing Grant Program.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 20 That the Laws of Maryland read as follows:

- 1 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS 2 INDICATED.
- 3 (B) "EXECUTIVE DIRECTOR" MEANS THE EXECUTIVE DIRECTOR OF THE 4 GOVERNOR'S OFFICE OF CRIME CONTROL AND PREVENTION.
- 5 (C) "INTERJURISDICTIONAL POLICING AGREEMENT" MEANS AN 6 AGREEMENT BETWEEN TWO OR MORE COUNTIES TO COOPERATE ON LAW 7 ENFORCEMENT ACTIVITIES.
- 8 (D) "PROGRAM" MEANS THE INTERJURISDICTIONAL POLICING GRANT 9 PROGRAM.

- 11 (A) THERE IS A GRANT PROGRAM ADMINISTERED BY THE EXECUTIVE 12 DIRECTOR KNOWN AS THE INTERJURISDICTIONAL POLICING GRANT PROGRAM.

- 5 (C) A GRANT AWARDED UNDER THIS SECTION:
- 6 (1) SHALL BE COMMENSURATE WITH:
- 7 (I) THE POPULATION AND GEOGRAPHIC SIZE OF THE COUNTIES
- 8 APPLYING FOR THE GRANT; AND
- 9 (II) THE SCOPE OF THE INTERJURISDICTIONAL POLICING
- 10 AGREEMENT; AND
- 11 (2) IF THE INTERJURISDICTIONAL POLICING AGREEMENT SPANS
- 12 MULTIPLE YEARS, MAY BE SPREAD ACROSS MULTIPLE FISCAL YEARS.

- 14 (A) A COUNTY THAT RECEIVES A GRANT FROM THE PROGRAM SHALL, IN A
- 15 MANNER APPROVED BY THE EXECUTIVE DIRECTOR, ANNUALLY SUBMIT A REPORT
- 16 TO THE EXECUTIVE DIRECTOR ON THE USE OF GRANT FUNDS.
- 17 (B) THE EXECUTIVE DIRECTOR SHALL POST A REPORT SUBMITTED UNDER
- 18 SUBSECTION (A) OF THIS SECTION TO THE GOVERNOR'S OFFICE OF CRIME
- 19 CONTROL AND PREVENTION WEBSITE.
