- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

2 3	(a) (1) The Department shall provide uniforms and equipment necessary for the performance of the duties of employees in accordance with the State budget.
4 5 6	(2) Uniforms and equipment shall be purchased by the Department in accordance with Division II of the State Finance and Procurement Article and remain the property of the State.
7 8 9	(b) (1) Subject to paragraph (2) of this subsection, the Secretary may grant permission to off-duty police employees to use police vehicles during off-duty hours if, in the opinion of the Secretary, the vehicles will not be needed by on-duty police employees.
10 11	(2) Only the police employees to whom permission has been granted to use the police vehicles may operate the police vehicles.

15 16 17	On or before January 1, 2016, the Maryland Police Training and Standards Commission shall develop and publish online a policy for the issuance and use of a body—worn camera by a law enforcement officer that addresses:
18	(1) the testing of body-worn cameras to ensure adequate functioning;
19 20	(2) the procedure for the law enforcement officer to follow if the camera fails to properly operate at the beginning of or during the law enforcement officer's shift;
21	(3) when recording is mandatory;
22	(4) when recording is prohibited;
23	(5) when recording is discretionary;
24	(6) when recording may require consent of a subject being recorded;
25	(7) when a recording may be ended;
26	(8) providing notice of recording;
27	(9) access to and confidentiality of recordings;
28	(10) the secure storage of data from a body-worn camera;

- 12 (A) IN THIS SECTION, "LAW ENFORCEMENT OFFICER" HAS THE MEANING 13 STATED IN § 3–101(E) OF THIS TITLE.
- 14 (B) ON OR BEFORE JANUARY 1, 2021, THE DEPARTMENT OF STATE POLICE
  15 SHALL ADOPT POLICIES AND PROCEDURES FOR THE USE OF BODY-WORN CAMERAS
  16 CONSISTENT WITH THE POLICIES DEVELOPED BY THE MARYLAND POLICE
  17 TRAINING AND STANDARDS COMMISSION UNDER § 3–511 OF THIS SUBTITLE.
