A BILL

To designate certain land administered by the Bureau of Land Management and the Forest Service in the State of Oregon as wilderness and national recreation areas and to make additional wild and scenic river designations in the State of Oregon, and for other purposes.

2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

2 (a) **SHORT TITLE.**—This Act may be cited as the
3 “Oregon Wildlands Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) **SECRETARY.**—The term “Secretary”
9 means—

10 (A) the Secretary of the Interior, with re-
11 spect to public land administered by the Sec-
12 retary of the Interior; or

13 (B) the Secretary of Agriculture, with re-
14 spect to National Forest System land.

15 (2) **STATE.**—The term “State” means the State
16 of Oregon.

1 **TITLE I—OREGON NATIONAL**
 2 **RECREATION AREAS**

3 **SEC. 101. ROGUE CANYON AND MOLALLA NATIONAL**
 4 **RECREATION AREAS, OREGON.**

5 (a) DESIGNATION OF ROGUE CANYON AND MOLALLA
 6 NATIONAL RECREATION AREAS.—For the purposes of
 7 protecting, conserving, and enhancing the unique and na-
 8 tionally important recreational, ecological, scenic, cultural,
 9 watershed, and fish and wildlife values of the areas, the
 10 following areas in the State are designated as recreation
 11 areas for management by the Secretary in accordance with
 12 subsection (c):

13 (1) ROGUE CANYON NATIONAL RECREATION
 14 AREA.—The approximately 94,700 acres of Bureau
 15 of Land Management land, within the boundary gen-
 16 erally depicted on the map entitled “O&C Land
 17 Grant Act of 2014: Rogue Canyon National Recre-
 18 ation Area” and dated November 3, 2014, which is
 19 designated as the “Rogue Canyon National Recre-
 20 ation Area”.

21 (2) MOLALLA NATIONAL RECREATION AREA.—
 22 The approximately 24,100 acres of Bureau of Land
 23 Management land, within the boundary generally de-
 24 picted on the map entitled “O&C Land Grant Act of
 25 2014: Molalla National Recreation Area” and dated

1 November 3, 2014, which is designated as the
2 “Molalla National Recreation Area”.

3 (b) MAPS AND LEGAL DESCRIPTIONS.—

4 (1) IN GENERAL.—As soon as practicable after
5 the date of enactment of this Act, the Secretary
6 shall a prepare a map and legal description of each
7 area designated by subsection (a).

8 (2) EFFECT.—The maps and legal descriptions
9 prepared under paragraph (1) shall have the same
10 force and effect as if included in this Act, except
11 that the Secretary may correct any minor errors in
12 the maps and legal descriptions.

13 (3) PUBLIC AVAILABILITY.—The maps and
14 legal descriptions prepared under paragraph (1)
15 shall be available for public inspection in the appro-
16 priate offices of the Bureau of Land Management.

17 (c) ADMINISTRATION.—

18 (1) APPLICABLE LAW.—The Secretary shall ad-
19 minister each area designated by subsection (a)—

20 (A) in a manner that furthers the purposes
21 for which the area was established; and

22 (B) in accordance with any other applica-
23 ble Federal laws.

24 (2) USES.—The Secretary shall only allow uses
25 of an area designated by subsection (a) that are con-

1 sistent with the purposes and values for which the
2 area is established.

3 ~~(3) PROHIBITED USES.—~~The following shall be
4 prohibited on the areas designated by subsection
5 ~~(a)—~~

6 ~~(A) permanent roads;~~

7 ~~(B) commercial enterprises; and~~

8 ~~(C) except as necessary to meet the min-~~
9 ~~imum requirements for the administration of~~

15 ~~(4) WITHDRAWAL.—~~Subject to valid existing
16 ~~rights, all Federal surface and subsurface land with-~~
17 ~~in an area designated by subsection (a) is withdrawn~~

19 ~~(A) all forms of entry, appropriation, or~~
20 ~~disposal under the public land laws;~~

21 ~~(B) location, entry, and patent under the~~
22 ~~mining laws; and~~

23 ~~(C) laws pertaining to mineral and geo-~~
24 ~~thermal leasing and mineral materials.~~

1 (d) ADJACENT MANAGEMENT.—Nothing in this sec-
 2 tion creates any protective perimeter or buffer zone
 3 around an area designated by subsection (a).

8 **SEC. 201. ADDITIONS TO ROGUE WILD AND SCENIC RIVER.**

9 (a) IN GENERAL.—Section 3(a) of the Wild and Scenic Rivers Act (16 U.S.C. 1274(a)) is amended by striking
 10 paragraph (5) and inserting the following:
 11

12 “(5) ROGUE, OREGON.—

13 “(A) IN GENERAL.—The segment of the
 14 river extending from the mouth of the River
 15 downstream to the Lobster Creek Bridge, to be
 16 administered by the Secretary of the Interior or
 17 the Secretary of Agriculture, as agreed to by
 18 the Secretaries of the Interior and Agriculture
 19 or as directed by the President.

20 “(B) ADDITIONS.—In addition to the seg-
 21 ment described in subparagraph (A), there are
 22 designated the following segments in the Rogue
 23 River:

24 “(i) KELSEY CREEK.—The approxi-
 25 mately 6.8-mile segment of Kelsey Creek

1 from the Wild Rogue Wilderness boundary
 2 in T. 32 S., R. 9 W., sec. 25, Willamette
 3 Meridian, to the confluence with the Rogue
 4 River, as a wild river.

5 “(ii) EAST FORK KELSEY CREEK.—

6 “(I) SCENIC RIVER.—The ap-
 7 proximately 0.2-mile segment of East
 8 Fork Kelsey Creek from headwaters
 9 downstream to the Wild Rogue Wil-
 10 derness boundary in T. 33 S., R. 8
 11 W., sec. 5, Willamette Meridian, as a
 12 scenic river.

13 “(II) WILD RIVER.—The ap-
 14 proximately 4.6-mile segment of East
 15 Fork Kelsey Creek from the Wild
 16 Rogue Wilderness boundary in T. 33
 17 S., R. 8 W., sec. 5, Willamette Merid-
 18 ian, to the confluence with Kelsey
 19 Creek, as a wild river.

20 “(iii) WHISKY CREEK.—

21 “(I) RECREATIONAL RIVER.—
 22 The approximately 0.6-mile segment
 23 of Whisky Creek from the confluence
 24 of the East Fork and West Fork to

1 0.1 miles downstream from road ~~33-8-~~
 2 ~~23~~, as a recreational river.

3 “(II) WILD RIVER.—The ap-
 4 proximately 1.9-mile segment of Whis-
 5 ky Creek from 0.1 miles downstream
 6 from road ~~33-8-23~~ to the confluence
 7 with the Rogue River, as a wild river.

8 “(IV) EAST FORK WHISKY CREEK.—

9 “(I) SCENIC RIVER.—The ap-
 10 proximately 0.9-mile segment of East
 11 Fork Whisky Creek from its head-
 12 waters to Wild Rogue Wilderness
 13 boundary in T. 33 S., R. 8 W., sec.
 14 11, Willamette Meridian., as a scenic
 15 river.

16 “(II) WILD RIVER.—The ap-
 17 proximately 2.6-mile segment of East
 18 Fork Whisky Creek from the Wild
 19 Rogue Wilderness boundary in T. 33
 20 S., R. 8 W., sec. 11, Willamette Me-
 21 ridian., to 0.1 miles downstream of
 22 road ~~33-8-26~~ crossing, as a wild river.

23 “(III) RECREATIONAL RIVER.—
 24 The approximately 0.3-mile segment
 25 of East Fork Whisky Creek from 0.1

1 miles downstream of road 33-8-26 to
 2 the confluence with Whisky Creek, as
 3 a recreational river.

4 “(v) WEST FORK WHISKY CREEK.—

5 The approximately 4.8-mile segment of
 6 West Fork Whisky Creek from its head-
 7 waters to the confluence with the East
 8 Fork Whisky Creek, as a wild river.

9 “(vi) BIG WINDY CREEK.—

10 “(I) SCENIC RIVER.—The ap-
 11 proximately 1.5-mile segment of Big
 12 Windy Creek from its headwaters to
 13 0.1 miles downstream from road 34-9-
 14 17.1, as a scenic river.

15 “(II) WILD RIVER.—The ap-
 16 proximately 5.8-mile segment of Big
 17 Windy Creek from 0.1 miles down-
 18 stream from road 34-9-17.1 to the
 19 confluence with the Rogue River, as a
 20 wild river.

21 “(vii) EAST FORK BIG WINDY
 22 CREEK.—

23 “(I) SCENIC RIVER.—The ap-
 24 proximately 0.2-mile segment of East
 25 Fork Big Windy Creek from its head-

1 waters to 0.1 miles downstream from
2 road 34-8-36, as a scenic river.

3 “(II) WILD RIVER.—The ap-
4 proximately 3.7-mile segment of East
5 Fork Big Windy Creek from 0.1 miles
6 downstream from road 34-8-36 to the
7 confluence with Big Windy Creek, as
8 a wild river.

9 “(viii) LITTLE WINDY CREEK.—

10 “(I) SCENIC RIVER.—The ap-
11 proximately 1.2-mile segment of Little
12 Windy Creek from its headwaters to
13 the Wild Rogue Wilderness boundary
14 in T. 33 S., R. 9 W., sec. 34, Willam-
15 ette Meridian, as a scenic river.

16 “(II) WILD RIVER.—The ap-
17 proximately 1.9-mile segment of Little
18 Windy Creek from the Wild Rogue
19 Wilderness boundary in T. 33 S., R.
20 9 W., sec. 34, Willamette Meridian to
21 the confluence with the Rogue River,
22 as a wild river.

23 “(ix) HOWARD CREEK.—

24 “(I) SCENIC RIVER.—The ap-
25 proximately 0.3-mile segment of How-

1 ard Creek from its headwaters to 0.1
2 miles downstream of road 34-9-34, as
3 a scenic river.

4 “(H) WILD RIVER.—The ap-
5 proximately 6.9-mile segment of How-
6 ard Creek from 0.1 miles downstream
7 of road 34-9-34 to the confluence with
8 the Rogue River, as a wild river.

9 “(x) MULE CREEK.—

10 “(I) SCENIC RIVER.—The ap-
11 proximately 3.5-mile segment of Mule
12 Creek from its headwaters down-
13 stream to the Wild Rogue Wilderness
14 boundary as a scenic river.

15 “(H) WILD RIVER.—The ap-
16 proximately 7.8-mile segment of Mule
17 Creek from the Wild Rogue Wilder-
18 ness boundary in T. 32 S., R. 9 W.,
19 sec. 29, Willamette Meridian, to the
20 confluence with the Rogue River, as a
21 wild river.

22 “(xi) ANNA CREEK.—The approxi-
23 mately 3.5-mile segment of Anna Creek
24 from its headwaters to the confluence with
25 Howard Creek, as a wild river.

1 “(xii) MISSOURI CREEK.—

2 “(I) SCENIC RIVER.—The ap-
3 proximately 3.1-mile segment of Mis-
4 souri Creek from its headwaters
5 downstream to the Wild Rogue Wil-
6 derness boundary in T. 33 S., R. 10
7 W., sec. 24, Willamette Meridian, as a
8 scenic river.

9 “(II) WILD RIVER.—The ap-
10 proximately 1.6-mile segment of Mis-
11 souri Creek from the Wild Rogue Wil-
12 derness boundary in T. 33 S., R. 10
13 W., sec. 24, Willamette Meridian, to
14 the confluence with the Rogue River,
15 as a wild river.

16 “(xiii) JENNY CREEK.—

17 “(I) SCENIC RIVER.—The ap-
18 proximately 3.1-mile segment of
19 Jenny Creek from its headwaters
20 downstream to the Wild Rogue Wil-
21 derness boundary in T. 33 S., R. 9
22 W., sec. 28, Willamette Meridian, as a
23 scenic river.

24 “(II) WILD RIVER.—The ap-
25 proximately 1.8-mile segment of

1 Jenny Creek from the Wild Rogue
 2 Wilderness boundary in T. 33 S., R.
 3 9 W., sec. 28, Willamette Meridian, to
 4 the confluence with the Rogue River,
 5 as a wild river.

6 “(xiv) RUM CREEK.—

7 “(I) SCENIC RIVER.—The ap-
 8 proximately 2.2-mile segment of Rum
 9 Creek from its headwaters to the Wild
 10 Rogue Wilderness boundary in T. 34
 11 S., R. 8 W., sec. 9, Willamette Merid-
 12 ian, as a scenic river.

13 “(II) WILD RIVER.—The ap-
 14 proximately 2.2-mile segment of Rum
 15 Creek from the Wild Rogue Wilder-
 16 ness boundary in T. 34 S., R. 8 W.,
 17 sec. 9, Willamette Meridian, to the
 18 confluence with the Rogue River, as a
 19 wild river.

20 “(xv) EAST FORK RUM CREEK.—

21 “(I) SCENIC RIVER.—The ap-
 22 proximately 0.8-mile segment of East
 23 Fork Rum Creek from its headwaters
 24 to the Wild Rogue Wilderness bound-

1 ary in T. 34 S., R. 8 W., sec. 10,
2 Willamette Meridian, as a scenic river.

3 “(II) WILD RIVER.—The ap-
4 proximately 1.3-mile segment of East
5 Fork Rum Creek from the Wild
6 Rogue Wilderness boundary in T. 34
7 S., R. 8 W., sec. 10, Willamette Me-
8 ridian, to the confluence with Rum
9 Creek, as a wild river.

10 “(xvi) WILDCAT CREEK.—The ap-
11 proximately 1.7-mile segment of Wildeat
12 Creek from its headwaters downstream to
13 the confluence with the Rogue River, as a
14 wild river.

15 “(xvii) MONTGOMERY CREEK.—The
16 approximately 1.8-mile segment of Mont-
17 gomery Creek from its headwaters down-
18 stream to the confluence with the Rogue
19 River, as a wild river.

20 “(xviii) HEWITT CREEK.—

21 “(I) SCENIC RIVER.—The ap-
22 proximately 1.4-mile segment of Hew-
23 itt Creek from its headwaters to the
24 Wild Rogue Wilderness boundary in

1 T. 33 S., R. 9 W., sec. 19, Willamette Meridian, as a scenic river.

2
3 “(II) WILD RIVER.—The approximately 1.2-mile segment of Hewitt Creek from the Wild Rogue Wilderness boundary in T. 33 S., R. 9 W., sec. 19, Willamette Meridian, to the confluence with the Rogue River, as a wild river.

10 “(xix) BUNKER CREEK.—The approximately 6.6-mile segment of Bunker Creek from its headwaters to the confluence with the Rogue River, as a wild river.

15 “(I) SCENIC RIVER.—The approximately 0.8-mile segment of Dulog Creek from its headwaters to 0.1 miles downstream of road 34-8-36, as a scenic river.

20 “(II) WILD RIVER.—The approximately 1.0-mile segment of Dulog Creek from 0.1 miles downstream of road 34-8-36 to the confluence with the Rogue River, as a wild river.

1 “(xxi) QUAIL CREEK.—The approxi-
 2 mately 1.7-mile segment of Quail Creek
 3 from the Wild Rogue Wilderness boundary
 4 in T. 33 S., R. 10 W., sec. 1, Willamette
 5 Meridian, to the confluence with the Rogue
 6 River, as a wild river.

7 “(xxii) MEADOW CREEK.—The ap-
 8 proximately 4.1-mile segment of Meadow
 9 Creek from its headwaters to the con-
 10 fluence with the Rogue River, as a wild
 11 river.

12 “(xxiii) RUSSIAN CREEK.—

13 “(I) SCENIC RIVER.—The ap-
 14 proximately 0.1-mile segment of Rus-
 15 sian Creek from its headwaters to the
 16 Wild Rogue Wilderness boundary in
 17 T. 33 S., R. 8 W., sec. 20., Willam-
 18 ette Meridian, as a scenic river.

19 “(II) WILD RIVER.—The ap-
 20 proximately 2.5-mile segment of Rus-
 21 sian Creek from the Wild Rogue Wil-
 22 derness boundary in T. 33 S., R. 8
 23 W., sec. 20, Willamette Meridian, to
 24 the confluence with the Rogue River,
 25 as a wild river.

1 “(xxiv) ALDER CREEK.—The approxi-
2 mately 1.2-mile segment of Alder Creek
3 from its headwaters to the confluence with
4 the Rogue River, as a wild river.

5 “(xxv) BOOZE CREEK.—The approxi-
6 mately 1.5-mile segment of Booze Creek
7 from its headwaters to the confluence with
8 the Rogue River, as a wild river.

9 “(xxvi) BRONCO CREEK.—The ap-
10 proximately 1.8-mile segment of Bronco
11 Creek from its headwaters to the con-
12 fluence with the Rogue River, as a wild
13 river.

14 “(xxvii) COPSEY CREEK.—The ap-
15 proximately 1.5-mile segment of Copsey
16 Creek from its headwaters to the con-
17 fluence with the Rogue River, as a wild
18 river.

19 “(xxviii) CORRAL CREEK.—The ap-
20 proximately 0.5-mile segment of Corral
21 Creek from its headwaters to the con-
22 fluence with the Rogue River, as a wild
23 river.

24 “(xxix) COWLEY CREEK.—The ap-
25 proximately 0.9-mile segment of Cowley

1 Creek from its headwaters to the con-
 2 fluence with the Rogue River, as a wild
 3 river.

4 “(xxx) DITCH CREEK.—The approxi-
 5 mately 1.8-mile segment of Ditch Creek
 6 from the Wild Rogue Wilderness boundary
 7 in T. 33 S., R. 9 W., sec. 5, Willamette
 8 Meridian, to its confluence with the Rogue
 9 River, as a wild river.

10 “(xxxii) FRANCIS CREEK.—The ap-
 11 proximately 0.9-mile segment of Francis
 12 Creek from its headwaters to the con-
 13 fluence with the Rogue River, as a wild
 14 river.

15 “(xxxiii) LONG GULCH.—

16 “(I) SCENIC RIVER.—The ap-
 17 proximately 1.4-mile segment of Long
 18 Gulch from its headwaters to the Wild
 19 Rogue Wilderness boundary in T. 33
 20 S., R. 10 W., sec. 23, Willamette Me-
 21 ridian, as a scenic river.

22 “(II) WILD RIVER.—The ap-
 23 proximately 1.1-mile segment of Long
 24 Gulch from the Wild Rogue Wilder-
 25 ness boundary in T. 33 S., R. 10 W.,

1 see. 23, Willamette Meridian, to the
2 confluence with the Rogue River, as a
3 wild river.

4 “(xxxiii) BAILEY CREEK.—

5 “(I) SCENIC RIVER.—The ap-
6 proximately 1.4-mile segment of Bai-
7 ley Creek from its headwaters to the
8 Wild Rogue Wilderness boundary on
9 the west section line of T. 34 S., R.
10 8 W., sec. 14, Willamette Meridian, as
11 a scenic river.

12 “(II) WILD RIVER.—The ap-
13 proximately 1.7-mile segment of Bai-
14 ley Creek from the west section line of
15 T. 34 S., R. 8 W., sec. 14, Willamette
16 Meridian, to the confluence of the
17 Rogue River, as a wild river.

18 “(xxxiv) SHADY CREEK.—The ap-
19 proximately 0.7-mile segment of Shady
20 Creek from its headwaters to the con-
21 fluence with the Rogue River, as a wild
22 river.

23 “(xxxv) SLIDE CREEK.—

24 “(I) SCENIC RIVER.—The ap-
25 proximately 0.5-mile segment of Slide

1 Creek from its headwaters to 0.1
 2 miles downstream from road 33-9-6,
 3 as a scenic river.

4 “(H) WILD RIVER.—The ap-
 5 proximately 0.7-mile section of Slide
 6 Creek from 0.1 miles downstream of
 7 road 33-9-6 to the confluence with the
 8 Rogue River, as a wild river.

9 “(xxxvi) QUARTZ CREEK.—The ap-
 10 proximately 3.3-mile segment of Quartz
 11 Creek from its headwaters to its confluence
 12 with the North Fork Galice Creek, as a
 13 scenic river.

14 “(xxxvii) NORTH FORK GALICE
 15 CREEK.—The approximately 5.7-mile seg-
 16 ment of the North Fork Galice Creek from
 17 its headwaters to its confluence with Galice
 18 Creek, as a recreational river.”

19 (b) MANAGEMENT.—Each river segment designated
 20 by subparagraph (B) of section 3(a)(5) of the Wild and
 21 Scenic Rivers Act (16 U.S.C. 1274(a)(5)) (as added by
 22 subsection (a)) shall be managed as part of the Rogue
 23 Wild and Scenic River.

24 (c) WITHDRAWAL.—Subject to valid existing rights,
 25 the Federal land within the boundaries of the river seg-

1 ments designated by subparagraph (B) of section 3(a)(5)
 2 of the Wild and Scenic Rivers Act (16 U.S.C. 1274(a)(5))
 3 (as added by subsection (a)) is withdrawn from all forms
 4 of—

5 (1) entry, appropriation, or disposal under the
 6 public land laws;

7 (2) location, entry, and patent under the mining
 8 laws; and

9 (3) disposition under all laws pertaining to min-
 10 eral and geothermal leasing or mineral materials.

11 (d) ~~ADDITIONAL PROTECTIONS FOR ROGUE RIVER~~
 12 ~~TRIBUTARIES.—~~

13 (1) ~~LICENSING BY COMMISSION.—~~The Commis-
 14 sion shall not license the construction of any dam,
 15 water conduit, reservoir, powerhouse, transmission
 16 line, or other project works on or directly affecting
 17 any stream described in paragraph (4).

18 (2) ~~OTHER AGENCIES.—~~

19 (A) ~~IN GENERAL.—~~No department or
 20 agency of the United States shall assist by loan,
 21 grant, license, or otherwise in the construction
 22 of any water resources project on or directly af-
 23 fecting any stream segment that is described in
 24 paragraph (4), except to maintain or repair

1 water resources projects in existence on the
2 date of enactment of this Act.

3 (B) EFFECT.—Nothing in this paragraph
4 prohibits any department or agency of the
5 United States in assisting by loan, grant, li-
6 cense, or otherwise, a water resources project—

7 (i) the primary purpose of which is ec-
8 ological or aquatic restoration; and

9 (ii) that provides a net benefit to
10 water quality and aquatic resources.

11 (3) WITHDRAWAL.—Subject to valid existing
12 rights, the Federal land located within $\frac{1}{4}$ mile on ei-
13 ther side of the stream segments described in para-

19 “(II) 0.01 miles above Forest
20 Service Road 5325 to its confluence
21 with Elk River, as a scenic river.

22 “(vi) EAST FORK PANTHER CREEK.—
23 The approximately 3.0-mile segment of
24 East Fork Panther Creek from its head-

1 waters, to the confluence with Panther
2 Creek, as a wild river.

3 “(vii) WEST FORK PANTHER
4 CREEK.—The approximately 3.0-mile seg-
5 ment of West Fork Panther Creek from its
6 headwaters to the confluence with Panther
7 Creek as a wild river.

8 “(viii) LOST CREEK.—The approxi-
9 mately 1.0-mile segment of Lost Creek
10 from—

11 “(I) its headwaters to 0.01 miles
12 above Forest Service Road 5325, as a
13 wild river; and

25 with the Elk River, as a scenic river.

1 “(x) BLACKBERRY CREEK.—The ap-
 2 proximately 5.0-mile segment of Black-
 3 berry Creek from—

4 “(I) its headwaters to 0.01 miles
 5 above Forest Service Road 5325, as a
 6 wild river; and

7 “(II) 0.01 miles above Forest
 8 Service Road 5325 to its confluence
 9 with the Elk River, as a scenic river.

10 “(xi) MCCURDY CREEK.—The ap-
 11 proximately 1.0-mile segment of McCurdy
 12 Creek from—

13 “(I) its headwaters to 0.01 miles
 14 above Forest Service Road 5325, as a
 15 wild river; and

16 “(II) 0.01 miles above Forest
 17 Service Road 5325 to its confluence
 18 with the Elk River, as a scenic river.

19 “(xii) BEAR CREEK.—The approxi-
 20 mately 1.5-mile segment of Bear Creek
 21 from headwaters to the confluence with
 22 Bald Mountain Creek, as a recreational
 23 river.”.

4 the Secretary of the Interior as a recreational river.

5 “(218) NORTH FORK SILVER CREEK, OR-
6 EGON.—The approximately 6-mile segment from the
7 headwaters in T. 35 S., R. 9 W., sec. 1 downstream
8 to the edge of the Bureau of Land Management
9 boundary in T. 35 S., R. 9 W., sec. 17, Willamette
10 Meridian, to be administered by the Secretary of the
11 Interior as a recreational river.

12 “(219) JENNY CREEK, OREGON.—The approxi-
13 mately 17.6-mile segment from the Bureau of Land
14 Management boundary located at the north bound-
15 ary of the southwest quarter of the southeast quar-
16 ter of T. 38 S., R. 4 E., sec. 34, Willamette Merid-
17 ian, downstream to the Oregon State border, to be
18 administered by the Secretary of the Interior as a
19 scenic river.

20 “(220) SPRING CREEK, OREGON.—The approxi-
21 mately 1.1-mile segment from its source at Shoat
22 Springs in T. 40 S., R. 4 E., sec. 34, Willamette
23 Meridian, downstream to the confluence with Jenny
24 Creek in T. 41 S., R. 4 E., sec. 3, Willamette Merid-

1 ian, to be administered by the Secretary of the Inte-
2 rior as a scenic river.

3 “(221) LOBSTER CREEK, OREGON.—The ap-
4 proximately 5-mile segment from T. 15 S., R. 8 W.,
5 sec. 35, Willamette Meridian, downstream to the
6 edge of the Bureau of Land Management boundary
7 in T. 15 S., R. 8 W., sec. 15, Willamette Meridian,
8 to be administered by the Secretary of the Interior
9 as a recreational river.

10 “(222) ELK CREEK, OREGON.—The approxi-
11 mately 7.3-mile segment from its confluence with
12 Flat Creek near river mile 9, to the southern edge
13 of the Army Corps of Engineers boundary in T. 33
14 S., R. 1 E., sec. 30, Willamette Meridian, near river
15 mile 1.7, to be administered by the Secretary of the

18 **TITLE III—WILDERNESS AREAS**

19 **SEC. 301. EXPANSION OF WILD ROGUE WILDERNESS AREA.**

20 (a) DEFINITIONS.—In this section:

21 (1) COMMISSION.—The term “Commission”
22 means the Federal Energy Regulatory Commission.

23 (2) MAP.—The term “map” means the map en-
24 titled “Wild Rogue Wilderness Additions” and dated
25 June 12, 2013.

1 (3) WILDERNESS ADDITIONS.—The term “Wil-
 2 derness additions” means the land added to the Wild
 3 Rogue Wilderness under subsection (b)(1).

4 (b) EXPANSION OF WILD ROGUE WILDERNESS
 5 AREA.—

6 (1) EXPANSION.—The approximately 56,100
 7 acres of Federal land in the State generally depicted
 8 on the map as “BLM Proposed Wilderness” and
 9 “Proposed USFS Wilderness” shall be added to and
 10 administered as part of the Wild Rogue Wilderness
 11 in accordance with the Endangered American Wil-
 12 derness Act of 1978 (16 U.S.C. 1132 note; Public
 13 Law 95-237), except that—

14 (A) the Secretary of the Interior and the
 15 Secretary of Agriculture shall administer the
 16 Federal land under their respective jurisdiction;
 17 and

18 (B) any reference in that Act to the Sec-
 19 retary of Agriculture shall be considered to be
 20 a reference to the Secretary of Agriculture or
 21 the Secretary of the Interior, as applicable.

22 (2) MAP; LEGAL DESCRIPTION.—

23 (A) IN GENERAL.—As soon as practicable
 24 after the date of enactment of this Act, the Sec-
 25 retary shall prepare a map and legal description

1 of the wilderness area designated by paragraph
2 (1).

3 (B) FORCE OF LAW.—The map and legal
4 description filed under subparagraph (A) shall
5 have the same force and effect as if included in
6 this section, except that the Secretary may cor-
7 rect typographical errors in the map and legal
8 description.

9 (C) PUBLIC AVAILABILITY.—The map and
10 legal description filed under subparagraph (A)
11 shall be on file and available for public inspec-
12 tion in the appropriate offices of the Bureau of
13 Land Management and Forest Service.

14 (3) CORRECTION.—Section 3(b) of the Endan-
15 gered American Wilderness Act of 1978 (16 U.S.C.
16 1132 note; Public Law 95-237) is amended by strik-
17 ing “3(a)(5)” and inserting “3(a)(5)(A)”.

18 (4) WITHDRAWAL.—Subject to valid existing
19 rights, the Wilderness additions are withdrawn from
20 all forms of—

21 (A) entry, appropriation, or disposal under
22 the public land laws;

23 (B) location, entry, and patent under the
24 mining laws; and

1 (C) disposition under all laws pertaining to
2 mineral and geothermal leasing or mineral ma-
3 terials.

4 (5) TRIBAL RIGHTS.—Nothing in this sub-
5 section alters, modifies, enlarges, diminishes, or ab-
6 rogates the treaty rights of any Indian tribe.

7 (c) POTENTIAL ADDITION TO WILDERNESS AREA.—

8 (1) DESIGNATION.—Subject to paragraph (3)
9 and in furtherance of the purposes of the Wilderness
10 Act (16 U.S.C. 1131 et seq.), certain public land in
11 the State administered by the Secretary of the Inte-
12 rior, comprising approximately 600 acres, as gen-
13 erally depicted on the map as “Potential Wilder-
14 ness”, shall be added to and administered as part of
15 the Wild Rogue Wilderness.

16 (2) INTERIM MANAGEMENT.—Subject to valid
17 existing rights, the Secretary shall manage the land
18 described in paragraph (1) to protect its suitability
19 for designation as wilderness until the date on which
20 the land is designated as wilderness in accordance
21 with paragraph (3).

22 (3) WILDERNESS DESIGNATION.—

23 (A) IN GENERAL.—The land described in
24 paragraph (1) shall be designated as wilderness
25 and added to and administered as part of the

1 Wild Rogue Wilderness on the date on which
2 the Secretary publishes in the Federal Register
3 notice that the conditions in the potential wil-
4 derness area that are incompatible with the
5 Wilderness Act (16 U.S.C. 1131 et seq.) have
6 been removed.

7 (B) ADMINISTRATION.—On designation as
8 wilderness under paragraph (1), the land de-
9 scribed in that paragraph shall be administered
10 in accordance with this Act, the Wilderness Act
11 (16 U.S.C. 1131 et seq.), and Public Law 95-
12 237 (16 U.S.C. 1132 note; 92 Stat. 40).

13 (4) WITHDRAWAL.—Subject to valid existing
14 rights, the land described in paragraph (1) is with-
15 drawn from all forms of—

16 (A) entry, appropriation, or disposal under
17 the public land laws;

18 (B) location, entry, and patent under the
19 mining laws; and

20 (C) disposition under all laws pertaining to
21 mineral and geothermal leasing or mineral ma-
22 terials.

23 (d) WITHDRAWAL AREA PROTECTIONS.—

24 (1) IN GENERAL.—The Secretary shall manage
25 the Federal land described in paragraph (2) in a

1 manner that preserves the natural and primitive
2 character of the land for recreational, scenic, and
3 scientific use.

4 (2) DESCRIPTION OF THE LAND.—The Federal
5 land referred to in paragraph (1) is the approxi-
6 mately 4,000 acres generally depicted on the map as
7 “Withdrawal Area”.

8 (3) MAPS AND LEGAL DESCRIPTIONS.—

9 (A) IN GENERAL.—As soon as practicable
10 after the date of enactment of this Act, the Sec-
11 retary shall prepare a map and legal description
12 of the land described in paragraph (2).

13 (B) FORCE OF LAW.—The map and legal
14 description filed under subparagraph (A) shall
15 have the same force and effect as if included in
16 this section, except that the Secretary may cor-
17 rect typographical errors in the map and legal
18 description.

19 (C) PUBLIC AVAILABILITY.—The map and
20 legal description filed under subparagraph (A)
21 shall be on file and available for public inspec-
22 tion in the appropriate offices of the Bureau of
23 Land Management.

24 (4) USE OF LAND.—

1 (A) ~~IN GENERAL.~~—Subject to valid exist-
2 ing rights, with respect to the Federal land de-
3 scribed in paragraph (2), the Secretary shall
4 only allow uses that are consistent with the pur-
5 poses described in paragraph (1).

6 (B) ~~PROHIBITED USES.~~—The following
7 shall be prohibited on the Federal land de-
8 scribed in paragraph (2):

9 (i) Permanent roads.

10 (ii) Commercial enterprises.

11 (iii) Except as necessary to meet the
12 minimum requirements for the administra-
13 tion of the Federal land and to protect
14 public health and safety—

15 (I) the use of motor vehicles; or

16 (II) the establishment of tem-
17 porary roads.

18 (5) ~~WITHDRAWAL.~~—Subject to valid existing
19 rights, the Federal land described in paragraph (2)
20 is withdrawn from—

21 (A) all forms of entry, appropriation, or
22 disposal under the public land laws;

23 (B) location, entry, and patent under the
24 mining laws; and

1 (C) disposition under all laws relating to
2 mineral and geothermal leasing or mineral ma-

11 **SEC. 301. EXPANSION OF WILD ROGUE WILDERNESS AREA.**

12 *(a) DEFINITIONS.—In this section:*

13 *(1) MAP.—The term “map” means the map enti-*
 14 *tled “Rogue Canyon Recreation Area Wild Rogue*
 15 *Wilderness Additions” and dated October 10, 2018.*

16 *(2) WILDERNESS ADDITIONS.—The term “Wil-*
 17 *derness additions” means the land added to the Wild*
 18 *Rogue Wilderness under subsection (b)(1).*

19 *(b) EXPANSION OF WILD ROGUE WILDERNESS*
 20 *AREA.—*

21 *(1) EXPANSION.—The approximately 59,512*
 22 *acres of Federal land in the State generally depicted*
 23 *on the map as “Proposed Wilderness” shall be added*
 24 *to and administered as part of the Wild Rogue Wil-*
 25 *derness in accordance with the Endangered American*

1 *Wilderness Act of 1978 (16 U.S.C. 1132 note; Public*
2 *Law 95-237), except that—*

3 *(A) the Secretary of the Interior and the*

8 (B) *location, entry, and patent under the*
9 *mining laws; and*

10 (C) *disposition under all laws pertaining to*
11 *mineral and geothermal leasing or mineral ma-*
12 *terials.*

13 (4) *TRIBAL RIGHTS.—Nothing in this subsection*
14 *alters, modifies, enlarges, diminishes, or abrogates the*
15 *treaty rights of any Indian tribe.*

16 **SEC. 302. DEVIL’S STAIRCASE WILDERNESS.**

17 (a) *DEFINITIONS.—In this section:*

18 (1) *MAP.—The term “map” means the map enti-*
19 *tled “Devil’s Staircase Wilderness Proposal” and*
20 *dated July 26, 2018.*

21 (2) *WILDERNESS.—The term “Wilderness”*
22 *means the Devil’s Staircase Wilderness designated by*
23 *subsection (b).*

24 (b) *DESIGNATION.—In accordance with the Wilderness*
25 *Act (16 U.S.C. 1131 et seq.), the approximately 30,621*

1 *acres of Forest Service land and Bureau of Land Manage-*
2 *ment land in the State, as generally depicted on the map,*
3 *is designated as wilderness and as a component of the Na-*
4 *tional Wilderness Preservation System, to be known as the*
5 *“Devil’s Staircase Wilderness”.*

6 (c) *MAP; LEGAL DESCRIPTION.—*

7 (1) *IN GENERAL.—As soon as practicable after*
8 *the date of enactment of this Act, the Secretary shall*
9 *prepare a map and legal description of the Wilder-*
10 *ness.*

11 (2) *FORCE OF LAW.—The map and legal descrip-*
12 *tion prepared under paragraph (1) shall have the*
13 *same force and effect as if included in this Act, except*
14 *that the Secretary may correct clerical and typo-*
15 *graphical errors in the map and legal description.*

16 (3) *AVAILABILITY.—The map and legal descrip-*
17 *tion prepared under paragraph (1) shall be on file*
18 *and available for public inspection in the appropriate*
19 *offices of the Forest Service and Bureau of Land*
20 *Management.*

21 (d) *ADMINISTRATION.—Subject to valid existing*
22 *rights, the area designated as wilderness by this section*
23 *shall be administered by the Secretary in accordance with*
24 *the Wilderness Act (16 U.S.C. 1131 et seq.), except that—*

1 (1) *any reference in that Act to the effective date*
2 *shall be considered to be a reference to the date of en-*
3 *actment of this Act; and*

4 (2) *any reference in that Act to the Secretary of*
5 *Agriculture shall be considered to be a reference to the*
6 *Secretary that has jurisdiction over the land within*
7 *the Wilderness.*

8 (e) *FISH AND WILDLIFE.*—*Nothing in this section af-*
9 *fects the jurisdiction or responsibilities of the State with*
10 *respect to fish and wildlife in the State.*

11 (f) *ADJACENT MANAGEMENT.*—

12 (1) *IN GENERAL.*—*Nothing in this section creates*
13 *any protective perimeter or buffer zone around the*
14 *Wilderness.*

15 (2) *ACTIVITIES OUTSIDE WILDERNESS.*—*The fact*
16 *that a nonwilderness activity or use on land outside*
17 *the Wilderness can be seen or heard within the Wil-*
18 *derness shall not preclude the activity or use outside*
19 *the boundary of the Wilderness.*

20 (g) *PROTECTION OF TRIBAL RIGHTS.*—*Nothing in this*
21 *section diminishes any treaty rights of an Indian tribe.*

22 (h) *TRANSFER OF ADMINISTRATIVE JURISDICTION.*—

23 (1) *IN GENERAL.*—*Administrative jurisdiction*
24 *over the approximately 49 acres of Bureau of Land*
25 *Management land north of the Umpqua River in T.*

1 *21 S., R. 11 W., sec. 32, is transferred from the Bu-*
2 *reau of Land Management to the Forest Service.*

3 *(2) ADMINISTRATION.—The Secretary shall ad-*
4 *minister the land transferred by paragraph (1) in ac-*
5 *cordance with—*

6 *(A) the Act of March 1, 1911 (commonly*
7 *known as the “Weeks Law”) (16 U.S.C. 480 et*
8 *seq.); and*

9 *(B) any laws (including regulations) appli-*
10 *cable to the National Forest System.*
