1	AN ACT relating to police pursuit policies and making an appropriation therefor.
2	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
3	→SECTION 1. A NEW SECTION OF KRS CHAPTER 61 IS CREATED TO
4	READ AS FOLLOWS:
5	(1) As used in this section, ''law enforcement agency'' means:
6	(a) Any public agency that employs a police officer as defined in KRS 15.420 or
7	a special law enforcement officer as defined by KRS 61.900;
8	(b) Any public agency that is composed of or employs other public peace
9	officers; and
10	(c) Any elected or appointed peace officer who is authorized to exercise powers
11	of a peace officer as defined in KRS 446.010.
12	(2) On or after January 1, 2021, each law enforcement agency of this state shall
13	adopt, implement, enforce, and maintain written policies that establish standards
14	and procedures for the vehicular pursuit of any person who has violated or is
15	suspected of violating the laws of this state. The policy shall create guidelines for
16	determining when the interests of public safety and effective law enforcement
17	justify the initiation or termination of a vehicular pursuit. The policy shall
18	address the following subjects:
19	(a) The definition of pursuit that will be governed under the law enforcement
20	agency's policy;
21	(b) Decision-making criteria or principles that are designed to assist peace
22	officers in determining whether to initiate a pursuit. The criteria or
23	principles may include, but shall not be limited to:
24	1. The potential for harm or potential danger to others if the fleeing
25	individual evades or escapes immediate custody;
26	2. The seriousness of the offense committed or believed to be committed,
2.7	by the fleeing individual or individuals, prior to the officer activating

1		emergency equipment.
2		3. If the officer has a reasonable and articulable suspicion that the driver
3		or an occupant of the vehicle in which they are fleeing represent a
4		clear and present danger to the public safety;
5		4. Safety factors that pose a risk to peace officers, other motorists,
6		pedestrians, or other third parties;
7		5. Vehicular or pedestrian traffic safety and volume;
8		6. Weather and vehicle conditions;
9		7. Potential speeds of the pursuit; and
10		8. Consideration of whether the identity of an offender is known and
11		could be apprehended at a later time;
12	<u>(c)</u>	Responsibilities of the pursing peace officer or officers, including pursuit
13		tactics and when those tactics are appropriate for use by the officer or
14		officers;
15	<u>(d)</u>	Procedures for designating the primary pursuit vehicle and for determining
16		the total number of vehicles that are permitted to participate at one (1) time
17		in the pursuit;
18	<u>(e)</u>	Coordination of communications during the pursuit, including but not
19		limited to responsibilities of the pursuing officer to communicate with his or
20		her communications center at the commencement of a pursuit regarding
21		the location, direction of travel, reason for the pursuit, and ongoing status
22		reporting during the pursuit;
23	<u>(f)</u>	A requirement that there is supervisory control of the pursuit, including the
24		responsibilities of command staff or other supervisors during the pursuit, if
25		a supervisor is available;
26	<u>(g)</u>	The circumstances and conditions where the use of pursuit intervention
27		tactics, including but not limited to, blocking, ramming, boxing, and

I		roadblock procedures may be employed;
2		(h) Decision-making criteria or principles that are designed to assist peace
3		officers in making an on-going determination during the course of the
4		pursuit of whether to continue the pursuit or to terminate or discontinue it.
5		The criteria or principles may include, but shall not be limited to:
6		1. The potential for harm or potential danger to others if the fleeing
7		individual evades or escapes immediate custody;
8		2. The seriousness of the offense committed or believed to have been
9		committed by the individual or individuals that are fleeing;
10		3. Safety factors that pose a risk to peace officers, other motorists,
11		pedestrians, or other third parties;
12		4. Vehicular or pedestrian traffic safety and volume;
13		5. Weather and vehicle conditions;
14		6. Speeds of the pursuit;
15		7. Consideration of whether the identity of an offender is known and
16		could be apprehended at a later time; or
17		8. Where the officer has a reasonable and articulable suspicion that the
18		driver or an occupant of the vehicle in which they are fleeing
19		represent a clear and present danger to the public safety;
20		(i) Procedures for coordinating the pursuit with other law enforcement
21		agencies, including procedures for interjurisdictional pursuits; and
22		(j) A process for reporting and evaluating each pursuit by the law enforcement
23		agency.
24	<u>(3)</u>	The policy adopted by a law enforcement agency may be a model policy that has
25		been endorsed by a national or state organization if the model complies with
26		subsection (2) of this section and other laws of this Commonwealth.
27	<i>(4)</i>	Upon the initial adoption of the policy, a law enforcement agency shall cause a

1		full copy of its policy to be filed with the Justice Cabinet, which shall maintain a
2		list of law enforcement agencies that have complied with the requirements of this
3		section. If a law enforcement agency fails to comply with the requirements of this
4		section, the Justice Cabinet shall notify all state agencies to suspend delivery of
5		all discretionary payments of state funds or state-administered federal funds to a
6		noncompliant law enforcement agency during its period of noncompliance.
7	<u>(5)</u>	Each law enforcement agency shall receive and maintain written confirmation
8		from each officer in its employment that he or she has received a copy of the
9		policy, and that he or she has received instruction or training specific to the law
10		enforcement agency's policy. The failure of any officer to provide certification
11		shall not be used to impose liability on an individual officer or law enforcement
12		agency.
13	<u>(6)</u>	Any policy adopted pursuant to this section or any model developed by any public
14		agency for use by law enforcement agencies to achieve compliance with this
15		section shall remain confidential and shall not be subject to disclosure under
16		KRS 61.870 to 61.884.
17	<u>(7)</u>	Any policy adopted pursuant to this section, shall be reviewed annually and may
18		be revised at any time by the agency adopting it. The agency shall cause a full
19		copy of its revised policy to be filed with the Justice Cabinet.
20	<u>(8)</u>	The requirements of this section are solely intended to direct law enforcement
21		agencies to adopt, implement, enforce, and maintain written vehicular pursuit
22		policies and outline the subjects of these policies. This section shall not be
23		interpreted or construed to:
24		(a) Mandate the actions of individual peace officers of a law enforcement
25		agency during any particular pursuit;
26		(b) Restrict a law enforcement agency from adopting additional policy
27		requirements, including policies that limit or prohibit vehicular pursuits; or

1		<u>(c)</u>	Create any civil liability upon peace officers, law enforcement agencies, or
2			any public agency that has created or is responsible for the oversight of the
3			law enforcement agency.

As the exclusive method by which the number of hours required for basic training courses shall be modified from that which is specifically established by this paragraph, the council may, by the promulgation of administrative regulations in accordance with the provisions of KRS Chapter 13A, explicitly set the exact number of hours for basic training at a number different from nine hundred twenty-eight (928) hours based upon a training curriculum approved by the Kentucky Law Enforcement Council as determined by a validated job task analysis.
 - 3. If the council sets an exact number of hours different from nine hundred twenty-eight (928) in an administrative regulation as provided by this paragraph, it shall not further change the number of hours required for basic training without promulgating administrative regulations in accordance with the provisions of KRS Chapter 13A.
 - 4. Nothing in this paragraph shall be interpreted to prevent the council, pursuant to its authority under KRS 15.330, from approving training

schools with a curriculum requiring attendance of a number of hours that exceeds nine hundred twenty-eight (928) hours or the number of hours established in an administrative regulation as provided by subparagraphs 2. and 3. of this paragraph. However, the training programs and schools for the basic training of law enforcement personnel conducted by the department pursuant to KRS 15A.070 shall not contain a curriculum that requires attendance of a number of hours for basic training that is different from nine hundred twenty-eight (928) hours or the number of hours established in an administrative regulation promulgated by the 10 council pursuant to the provisions of KRS Chapter 13A as provided by subparagraphs 2. and 3. of this paragraph.

- 5. KRS 15.400 and 15.404(1), and subparagraphs 1. to 4. of this paragraph to the contrary notwithstanding, the council may, through the promulgation of administrative regulations in accordance with KRS Chapter 13A, approve basic training credit for:
 - a. Years of service credit as a law enforcement officer with previous service in another state; and
 - b. Basic training completed in another state;
- (e) Requires all police officers to successfully complete each calendar year an inservice training course, appropriate to the officer's rank and responsibility and the size and location of the officer's police department, of forty (40) hours' duration, of which eight (8) hours shall be in emergency vehicle operation the number of hours shall not be changed by the council, at a school certified or recognized by the council. The number of hours required shall not be changed by the council. This in-service training requirement shall be waived for the period of time that a peace officer is serving on active duty in the United States Armed Forces. This waiver shall be retroactive for peace

officers from the date of September 11, 2001;

(f) Complies with all provisions of law applicable to police officers or police departments, including transmission of data to the centralized criminal history record information system as required by KRS 17.150 and transmission of reports as required by KRS 15.391;

- (g) Complies with all rules and regulations, appropriate to the size and location of the police department issued by the cabinet to facilitate the administration of the fund and further the purposes of KRS 15.410 to 15.510;
- (h) Possesses a written policy and procedures manual related to domestic violence for law enforcement agencies that has been approved by the cabinet. The policy shall comply with the provisions of KRS 403.715 to 403.785. The policy shall include a purpose statement; definitions; supervisory responsibilities; procedures for twenty-four (24) hour access to protective orders; procedures for enforcement of court orders or relief when protective orders are violated; procedures for timely and contemporaneous reporting of adult abuse and domestic violence to the Cabinet for Health and Family Services, Department for Community Based Services; victim rights, assistance, and service responsibilities; and duties related to timely completion of records; and
- (i) Possesses by January 1, 2017, a written policy and procedures manual related to sexual assault examinations that meets the standards provided by, and has been approved by, the cabinet, and which includes:
 - A requirement that evidence collected as a result of an examination performed under KRS 216B.400 be taken into custody within five (5) days of notice from the collecting facility that the evidence is available for retrieval;
 - 2. A requirement that evidence received from a collecting facility relating

1	to an incident which occurred outside the jurisdiction of the police
2	department be transmitted to a police department with jurisdiction
3	within ten (10) days of its receipt by the police department;

- 3. A requirement that all evidence retrieved from a collecting facility under this paragraph be transmitted to the Department of Kentucky State Police forensic laboratory within thirty (30) days of its receipt by the police department;
- A requirement that a suspect standard, if available, be transmitted to the Department of Kentucky State Police forensic laboratory with the evidence received from a collecting facility; and
- 5. A process for notifying the victim from whom the evidence was collected of the progress of the testing, whether the testing resulted in a match to other DNA samples, and if the evidence is to be destroyed. The policy may include provisions for delaying notice until a suspect is apprehended or the office of the Commonwealth's attorney consents to the notification, but shall not automatically require the disclosure of the identity of any person to whom the evidence matched.
- (2) A unit of government which meets the criteria of this section shall be eligible to continue sharing in the distribution of funds from the Law Enforcement Foundation Program fund only if the police department of the unit of government remains in compliance with the requirements of this section.
- Deputies employed by a sheriff's office shall be eligible to participate in the distribution of funds from the Law Enforcement Foundation Program fund regardless of participation by the sheriff.
- 25 (4) Failure to meet a deadline established in a policy adopted pursuant to subsection 26 (1)(i) of this section for the retrieval or submission of evidence shall not be a basis 27 for a dismissal of a criminal action or a bar to the admissibility of the evidence in a

(3) The cabinet, upon receiving a record of the conviction of any person upon a charge of operating a motor vehicle while the license of that person is denied, or suspended, or revoked, or while his privilege to operate a motor vehicle is withdrawn, shall immediately extend the period of the first denial, suspension, revocation, or withdrawal for an additional like period.

- (4) The revocation or denial of a license or the withdrawal of the privilege of operating a motor vehicle for a violation of subsection (1)(a)1. of this section shall be for a period of not less than five (5) years. Revocations or denials under this section shall not be subject to any lessening of penalties authorized under any other provision of this section or any other statute.

- 11 (7) The cabinet shall revoke the license of any operator of a motor vehicle upon 12 receiving notification that the person is under age eighteen (18) and has dropped out 13 of school or is academically deficient, as defined in KRS 159.051(1).
- 14 (8) A person under the age of eighteen (18) who is convicted of the offenses of
 15 subsections (1) or (3) of this section, except for subsection (1)(a)8. or 9. of this
 16 section, shall have his license revoked until he reaches the age of eighteen (18) or

- 25 (a) As a pedestrian, and with intent to elude or flee, the person knowingly or wantonly disobeys a direction to stop, given by a person recognized to be a peace officer who has an articulable reasonable suspicion that a crime has

1		been committed by the person fleeing, and in fleeing or eluding the person is
2		the cause of, or creates a substantial risk of, physical injury to any person; or
3		(b) While operating a motor vehicle with intent to elude or flee, the person
4		knowingly or wantonly disobeys a recognized direction to stop his vehicle,
5		given by a person recognized to be a peace officer.
6	(2)	No offense is committed under this section when the conduct involved constitutes a
7		failure to comply with a directive of a traffic control officer.
8	(3)	Fleeing or evading police in the second degree is a Class A misdemeanor. <u>In</u>
9		addition, the court shall suspend the driver's license of any person who is
10		convicted of fleeing or evading the police in the second degree for a period of not
11		less than thirty (30) days nor more than one (1) year. The court shall suspend the
12		driver's license of any person under the age of eighteen (18) who is convicted of
13		fleeing or evading police in the second degree until the person reaches the age of
14		twenty-one (21).
15		→ Section 7. Section 1 of this Act may be cited as Jill's Law.
