143	(i) depict the commission of an alleged crime;
144	(ii) record any encounter between a law enforcement officer and a person that results in
145	death or bodily injury, or includes an instance when an officer fires a weapon;
146	(iii) record any encounter that is the subject of a complaint or a legal proceeding
147	against a law enforcement officer or law enforcement agency;

152 (3) (a) As used in this Subsection (3), "medical records" means medical reports, records, statements, history, diagnosis, condition, treatment, and evaluation. 153 154 (b) Medical records in the possession of the University of Utah Hospital, its clinics, doctors, or affiliated entities are not private records or controlled records under Section 155 156 63G-2-304 when the records are sought: 157 (i) in connection with any legal or administrative proceeding in which the patient's physical, mental, or emotional condition is an element of any claim or defense; or 158 159 (ii) after a patient's death, in any legal or administrative proceeding in which any party 160 relies upon the condition as an element of the claim or defense. 161 (c) Medical records are subject to production in a legal or administrative proceeding 162 according to state or federal statutes or rules of procedure and evidence as if the medical 163 records were in the possession of a nongovernmental medical care provider.
