- 2 tives of the United States of America in Congress assembled,

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "No Timber From Tyrants Act". 5

6 SEC. 2. PROHIBITION ON THE IMPORTATION OF WOOD AND 7 RELATED ARTICLES FROM THE RUSSIAN 8 **FEDERATION** AND THE REPUBLIC OF 9 BELARUS.

10 (a) IN GENERAL.—The President shall prohibit the 11 importation into the United States of all wood and related 12 articles classifiable under chapter 44 of the Harmonized Tariff Schedule of the United States that are determined 13 to originate from the Russian Federation or the Republic 14 15 of Belarus, without regard to whether such articles are shipped through third countries. 16

17 (b) **TERMINATION.**—The President may terminate the prohibition under subsection (a) with respect to either 18 19 the Russian Federation or the Republic of Belarus (or 20 both) beginning 90 days after the date on which the Presi-

dent certifies to Congress that the Russian Federation or 1 2 the Republic of Belarus (or both, as applicable)— 3 (1) has reached an agreement relating to the 4 respective withdrawal of Russian or Belarusian 5 forces (or both, if applicable) and cessation of mili-6 tary hostilities that is accepted by the free and inde-7 pendent Government of Ukraine; 8 (2) poses no immediate military threat of ag-9 gression to any North Atlantic Treaty Organization 10 member; and 11 (3) recognizes the right of the people of 12 Ukraine to independently and freely choose their 13 own government. 14 SEC. 3. TIMBER PRODUCTION TO REPLACE PROHIBITED 15 **IMPORTS.** 16 (a) IN GENERAL.—Notwithstanding any other provi-17 sion of law, the Secretary concerned— 18 (1) shall authorize timber harvest in an amount 19 sufficient to equal the volume, with respect to cal-20 endar year 2021, of imports of wood and related ar-21 ticles described in section 2; and 22 (2) may only authorize timber harvest under 23 paragraph (1)—

(A) on public lands or National Forest
 System lands designated as suitable for timber
 production; and

4 (B) in accordance with the allowable sale
5 quantity of timber applicable to such lands on
6 the date of the enactment of this Act.

7 (b) PROHIBITION.—The Secretary concerned shall 8 not approve any forest plan or land management plan revi-9 sion that reduces the allowable sale quantity of timber 10 under the plan unless the Secretary concerned submits a written explanation to the Committees on Agriculture and 11 Natural Resources of the House of Representatives and 12 13 Committees on Agriculture, Nutrition, and Forestry and Energy and Natural Resources of the Senate certifying 14 15 that such revision will not interfere with the obligations of the Secretary concerned under subsection (a). 16

17 (c) REPORT.—Not later than 1 year after the date
18 of enactment of this Act, the Secretary of Agriculture and
19 Secretary of the Interior shall each submit a report to the
20 Committees specified in subsection (b) that includes—

(1) a list of timber sales initiated and completed by the Secretary concerned to fulfill the obligations established under subsection (a); and

(2) a list of planned timber sales proposed by 1 2 the Secretary concerned to fulfill the obligations es-3 tablished under subsection (a). (d) SECRETARY CONCERNED DEFINED.—In this sec-4 tion, the term "Secretary concerned" means-5 (1) the Secretary of the Interior, with respect 6 7 to public lands; and (2) the Secretary of Agriculture, with respect to 8 9 National Forest System lands.
