AN ACT

- To direct the Secretary of Veterans Affairs to carry out a pilot program on the use of medical scribes in Department of Veterans Affairs medical centers, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1	SECTION 1. SHORT TITLE.				
2	This Act may be cited as the "Veterans Affairs Med-				
3	ical Scribe Pilot Act of 2017".				
4	SEC. 2. DEPARTMENT OF VETERANS AFFAIRS MEDICAL				
5	SCRIBE PILOT PROGRAM.				
6	(a) In General.—The Secretary of Veterans Affairs				
7	shall carry out a 2-year pilot program under which the				
8	Secretary shall increase the use of medical scribes at De-				
9	partment of Veterans Affairs medical centers.				
10	(b) Locations.—The Secretary shall carry out the				
11	pilot program at the 10 medical centers of the Department				
12	as follows:				
13	(1) At least four such medical centers located				
14	in rural areas.				
15	(2) At least four such medical centers located				
16	in urban areas.				
17	(3) Two such medical centers located in areas				
18	with need for increased access or increased effi-				
19	ciency, as determine by the Secretary.				
20	(e) Medical Scribes.—				
21	(1) Hiring.—Under the pilot program the Sec-				
22	retary shall—				
23	(A) hire 20 new Department of Veterans				

Affairs term employees as medical scribes; and

1	(B) seek to enter into contracts with ap-
2	propriate entities for the employment of 20 ad-
3	ditional medical scribes.
1	(2) Digmpipilmion The Secretary shall assign

- (2) DISTRIBUTION.—The Secretary shall assign four medical scribes to each of the 10 medical centers of the Department where the Secretary carries out the pilot program as follows:
 - (A) Two scribes shall be assigned to each of two physicians.
 - (B) Thirty percent of the scribes shall be employed in the provision of emergency care.
 - (C) Seventy percent of the scribes shall be employed in the provision of speciality care in specialties with the longest patient wait times or lowest efficiency ratings, as determined by the Secretary.

(d) Reports.—

(1) Reports to congress.—Not later than 180 days after the commencement of the pilot program required under this section, and every 180 days thereafter for the duration of the pilot program, the Secretary of Veterans Affairs shall submit to Congress a report on the pilot program. Each such report shall include each of the following:

1	(A) A separate analysis of each the fol-						
2	lowing with respect to medical scribes employed						
3	by the Department of Veterans Affairs and						
4	medical scribes performing Department of Vet-						
5	erans Affairs functions under a contract:						
6	(i) Provider efficiency.						
7	(ii) Patient satisfaction.						
8	(iii) Average wait time.						
9	(iv) The number of patients seen per						
10	day by each physician or practitioner.						
11	(v) The amount of time required to						
12	hire and train an employee to perform						
13	medical scribe functions under the pilot						
14	program.						
15	(B) Metrics and data for analyzing the ef-						
16	fects of the pilot program, including an evalua-						
17	tion of the each of the elements under clauses						
18	(i) through (iv) of subparagraph (A) at medical						
19	centers who employed scribes under the pilot						
20	program for an appropriate period preceding						
21	the hiring of such scribes.						
22	(2) Comptroller General Report.—Not						
23	later than 90 days after the termination of the pilot						
24	program under this section, the Comptroller General						
25	of the United States shall submit to Congress a re-						

- port on the pilot program. Such report shall include a comparison of the pilot program with similar programs carried out in the private sector.
 - (e) Definitions.—In this section:

- (1) The term "medical scribe" means an unlicensed individual hired to enter information into the electronic health record or chart at the direction of a physician or licensed independent practitioner whose responsibilities include the following:
 - (A) Assisting the physician or practitioner in navigating the electronic health record.
 - (B) Responding to various messages as directed by the physician or practitioner.
 - (C) Entering information into the electronic health record, as directed by the physician or practitioner.
- (2) The terms "urban" and "rural" have the meanings given such terms under the rural-urban commuting codes developed by the Secretary of Agriculture and the Secretary of Health and Human Services.
- 22 (f) Funding.—The pilot program under this section 23 shall be carried out using amounts otherwise authorized 24 to be appropriated for the Department of Veterans Af-

1	fairs. No additional amounts are authorized to be appro-				
2	priated to carry out such program.				
3	SEC. 3. PROHIBITION ON SMOKING IN FACILITIES OF TH				
4	VETERANS HEALTH ADMINISTRATION.				
5	(a) Prohibition.—Section 1715 of title 38, United				
6	States Code, is amended to read as follows:				
7	"§ 1715. Prohibition on smoking in facilities of the				
8	Veterans Health Administration				
9	"(a) Prohibition.—(1)(A) Except as provided in				
10	subparagraph (B), no person may smoke indoors in any				
11	facility of the Veterans Health Administration.				
12	"(B) In the case of a facility of the Veterans Health				
13	Administration that is a community living center, no per				
14	son may smoke indoors in such facility on or after Decem				
15	ber 31, 2018.				
16	"(2) No person may smoke outdoors in any facility				
17	of the Veterans Health Administration on or after October				
18	1, 2021.				
19	"(b) Definitions.—In this section:				
20	"(1) The term 'smoke' includes the smoking of				
21	cigarettes (including e-cigarettes or electronic ciga-				
22	rettes), cigars, pipes, and any other combustion of				
23	tobacco.				
24	"(2) The term 'facility of the Veterans Health				

Administration' means any land or building (includ-

1	ing any medical center, nursing home, domiciliary					
2	facility, outpatient clinic, or center that provides re-					
3	adjustment counseling) that is—					
4	"(A) under the jurisdiction of the Depar					
5	ment of Veterans Affairs;					
6	"(B) under the control of the Veteran					
7	Health Administration; and					
8	"(C) not under the control of the Gener					
9	Services Administration.					
10	"(3) The term 'community living center' mea					
11	a facility of the Department that provides nursin					
12	home care.".					
13	(b) Conforming Amendments.—					
14	(1) The table of sections at the beginning of					
15	chapter 17 of such title is amended by striking the					
16	item relating to section 1715 and inserting the fol-					
17	lowing:					
	"1715. Prohibition on smoking in facilities of the Veterans Health Administration.".					
18	(2) Section 526 of the Veterans Health Care					
19	Act of 1992 (Public Law 102–585) is repealed.					

- 1 (c) Effective Date.—This section shall take effect
- 2 90 days after the date of the enactment of this Act.
