A BILL

To amend title 31, United States Code, to reimburse employees of the Federal Government and the District of Columbia, Federal contractors, and the States for certain costs incurred as a result of a Government shutdown, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Pay Workers What
- 5 They've Earned Act".

SEC. 2. REIMBURSEMENT FOR INDIVIDUALS AFFECTED BY 2 GOVERNMENT SHUTDOWNS. 3 Section 1341 of title 31, United States Code, as amended by the Government Employee Fair Treatment 4 5 Act of 2019, is further amended by adding at the end the following: 6 7 "(d)(1) In this subsection— "(A) the term 'covered employee' means— 8 9 "(i) any employee of the United States 10 Government or of a District of Columbia public 11 employer furloughed as a result of a covered 12 lapse in appropriations; "(ii) any excepted employee who is re-13 14 quired to perform work during such lapse; and 15 "(iii) any contractor with the Federal Gov-16 ernment (or an employee of such contractor) 17 placed on unpaid leave as a result of such lapse; "(B) the term 'shutdown cost' means any cost 18 19 incurred by a covered employee as a direct result of 20 a covered lapse in appropriations, including expenses 21 for loans and credit cards, and any fees, fine, or in-22 terest resulting from the employees inability to make 23 payments as a direct result of a loss in salary due 24 to such lapse; "(C) the terms 'covered lapse in appropria-25 26 tions', 'District of Columbia public employer', 'em-

- 1 ployee', and 'excepted employee' have the meaning
- 2 given those terms in subsection (c); and
- 3 "(D) the term 'State' means any of the 50
- 4 States, the District of Columbia, the Commonwealth
- 5 of Puerto Rico, Guam, the Virgin Islands, American
- 6 Samoa, the Commonwealth of the Northern Mariana
- 7 Islands, and any territory or possession of the
- 8 United States, and includes Indian Tribes.
- 9 "(2)(A) With respect to the covered lapse in appro-
- 10 priations beginning on or about December 22, 2018, each
- 11 covered employee shall be paid for any shutdown cost at
- 12 the earliest date possible after the date of enactment of
- 13 this subsection, and subject to the enactment of appropria-
- 14 tions Acts ending the lapse.
- 15 "(B) With respect to any other covered lapse in ap-
- 16 propriations of a duration of 14 days or longer, any cov-
- 17 ered employee shall, subject to the availability of appro-
- 18 priations, be paid for any shutdown cost at the earliest
- 19 date possible after the lapse in appropriations ends.
- 20 "(3)(A) Any State that makes an expenditure of
- 21 State funds for payments for assistance programs that
- 22 would be, but for a covered lapse in appropriations of a
- 23 duration of 14 days or longer (including the lapse de-
- 24 scribed in subparagraph (A)), provided by the Federal

- 1 Government shall be reimbursed for such payments not
- 2 later than 90 days after the lapse in appropriations ends.
- 3 "(B) This paragraph shall not apply to any State ex-
- 4 penditure with respect to which reimbursement is provided
- 5 by the Federal Government under any other provision of
- 6 law, including unemployment compensation.
- 7 "(4)(A) In order to receive reimbursement under
- 8 paragraph (2) or (3), a covered employee or State (as the
- 9 case may be) shall submit an application to the Secretary
- 10 of the Treasury, in such form and manner as the Sec-
- 11 retary deems appropriate, not later than 1 year after the
- 12 applicable lapse in appropriations ends.
- 13 "(B) The Secretary shall determine what documenta-
- 14 tion shall be included with such an application to verify
- 15 the shutdown costs or expenditure submitted by a covered
- 16 employee or a State, respectively.
- 17 "(C) Upon approval by the Secretary, reimbursement
- 18 shall be provided to the covered employee or State, con-
- 19 sistent with the requirements of this subsection.
- 20 "(5)(A) There is established in the general fund of
- 21 the Treasury a fund, to be known as the 'Reserve Fund
- 22 for Employees Affected By Government Shutdowns' (in
- 23 this paragraph referred to as the 'Fund'), which shall con-
- 24 sist of amounts appropriated into the Fund after the date
- 25 of enactment of this subsection.

- 1 "(B) Subject to the availability of appropriations,
- 2 amounts in the Fund shall be available for purposes of
- 3 paying the shutdown costs of any covered employee during
- 4 a covered lapse in appropriations beginning after the lapse

5 referred to in paragraph (2)(A).".
