## AN ACT

- To state the policy of the United States with respect to the expansion of cooperation with allies and partners in the Indo-Pacific region and Europe regarding the People's Republic of China.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Indo-Pacific Coopera-
- 3 tion Act of 2019".

### 4 SEC. 2. FINDINGS.

- 5 Congress makes the following findings:
- 6 (1) Congress supports the finding on the Peo-
- 7 ple's Republic of China articulated in the 2018 Na-
- 8 tional Defense Strategy and the 2017 National Se-
- 9 curity Strategy.
- 10 (2) The Asia Reassurance Initiative Act of
- 11 2018 (Public Law 115–409) established the policy of
- the United States "to develop and commit to a long-
- term strategic vision and a comprehensive, multi-
- 14 faceted, and principled United States policy for the
- 15 Indo-Pacific region" so as to advance United States
- national security, economic, human rights, and other
- 17 regional interests, and for such purposes, Congress
- has authorized appropriate funding.
- 19 (3) The People's Republic of China is
- 20 leveraging military modernization, influence oper-
- ations, and predatory economics to coerce neigh-
- boring countries to reorder the Indo-Pacific region
- to the advantage of the People's Republic of China.
- 24 (4) As the People's Republic of China continues
- 25 its economic and military ascendance, asserting
- power through a whole of government long-term

- strategy, the People's Republic of China will continue to pursue a military modernization program that seeks Indo-Pacific regional hegemony in the near-term and displacement of the United States to achieve global preeminence in the future.
  - (5) A critical objective of the defense strategy of the United States is to set the military of the People's Republic of China on a path toward transparency and nonaggression.
    - (6) The People's Republic of China uses economic inducements and penalties, influence operations, and implied military threats to persuade other countries to heed the political and security agenda of the People's Republic of China.
  - (7) United States allies and partners are critical to effective competition with the People's Republic of China.

2	and partners, a unified approach to addressing and
3	deterring significant diplomatic, economic, and mili-
4	tary challenges posed by the People's Republic of
5	China; and
6	(3) to promote, in partnership with like-minded
7	countries around the globe, the values of democracy
8	and human rights.
