COMMENDATIONS: Commends Camphor Memorial United Methodist Church upon its one hundredth anniversary

A RESOLUTION

2	To commend Camphor Memorial United Methodist Church upon the historic occasion of
3	its one hundredth anniversary.
4	WHEREAS, it is appropriate to commemorate the historic occasion of the one
5	hundredth anniversary of Camphor Memorial United Methodist Church in Scotlandville; and
6	WHEREAS, in the early years of the last century no Methodist church existed in
7	Scotlandville, and a group of Methodists in that community would walk to worship each
8	Sunday morning at a church in the neighboring community of Baker; and
9	WHEREAS, in 1917, this devout group decided to bring a Methodist church to
10	Scotlandville and began meeting in the home of James and Mary Bradford on Marsh Street
11	to plan the church's establishment; and
12	WHEREAS, with the guidance of Reverend Amos M. Taylor of Thompson Chapel
13	in Baker and Reverend J. A. Landry, district superintendent, the founding group of ten
14	Scotlandville residents established in 1917 the Taylor Methodist Episcopal Church, the
15	forerunner of Camphor Memorial United Methodist Church; and
16	WHEREAS, the church's present name was bestowed upon it in 1922 in honor of
17	Bishop A. P. Camphor, a Louisiana-born minister and missionary; and
18	WHEREAS, also in 1922, Camphor Memorial United Methodist Church moved to
19	its current location at the corner of Scenic Highway and Teal Street; in that year, under the
20	direction of Reverend Walter Scott Chinn, the church building was rolled to that location
21	from the church's original site on Stilt Street; and

WHEREAS, in its century of existence, Camphor Memorial United Methodist 1 2 Church has not only met the spiritual needs of its congregation, but has been a leading 3 institution in civil rights and social justice as well; and 4 WHEREAS, Camphor currently serves its congregation and the community through an outreach center which provides food and clothing to the needy and through programs such 5 6 as Sisters Supporting Sisters, a support group for breast cancer patients and survivors, and Daughters of Naomi, which teaches life skills to girls; the church is also planning to hold a 7 8 workshop to teach men about ways to help their wives through illness; and 9 WHEREAS, for one hundred years, Camphor's congregants have steadfastly put faith 10 into action to transform their community and the world, and to be peak the love of Jesus 11 Christ, the light of the world; and 12 WHEREAS, the joyous occasion of the centennial of this church merits a special 13 measure of recognition. 14 THEREFORE, BE IT RESOLVED that the House of Representatives of the 15 Legislature of Louisiana does hereby commend Camphor Memorial United Methodist 16 Church in Scotlandville upon the historic occasion of its one hundredth anniversary, does 17 hereby record for posterity the rich and wonderful history of the church, and does hereby 18 extend best wishes for the church's continued vitality in its second century as it shares the 19 Good News and celebrates God's grace. 20 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted 21 to Reverend Clifton C. Conrad, pastor of Camphor Memorial United Methodist Church.
