  - 22 (a) There is a Class B–D–7 beer, wine, and liquor license.

1 (b) (1) The Board may issue a Class B–D–7 license if the Board determines 2 that the license is reasonably necessary for the convenience of the public.

3 (2) In making the determination, the Board shall consider the number of 4 beer, wine, and liquor outlets in a given area and the number of days the outlets are open, 5 rather than the nature of the outlets.

6 (c) The license authorizes the license holder to sell beer, wine, and liquor at retail 7 at the place described in the license, for on– and off–premises consumption.

8 (d) (1) Except as provided in paragraph (2) of this subsection, the license 9 holder may sell beer, wine, and liquor during the hours and days set out under § 12–2004(c) 10 of this title.

11 (2) The hours of sale for a license holder in an area bounded by Liberty 12 Heights Avenue, Northern Parkway, Druid Park Drive, and Wabash Avenue are from 9 13 a.m. to 9 p.m.

15 (c) Except as provided in § 12–2005 of this subtitle, a holder of a Class B–D–7 16 beer, wine, and liquor license may sell beer, wine, and liquor:

# 17 (1) FROM 9 A.M. TO 9 P.M. IN THE 4000 BLOCK OR THE 4100 BLOCK OF 18 FREDERICK ROAD;

19 [(1)] (2) from 9 a.m. to 10 p.m. in the area specified in the Park Heights 20 Master Plan adopted by the City in 2006; and

21[(2)] (3)from 6 a.m. to 2 a.m. the following day in all other locations in22the City.
