Public Schools - Agricultural Education and Grant Programs

3 FOR the purpose of requiring each county board of education, beginning in a certain school 4 year, to implement a certain agriculture science curriculum; requiring each county 5 board to implement an agricultural education program that prepares students for 6 successful careers and informed choices relating to certain systems and for 7 opportunities in agriculture-related employment and higher education by providing 8 instruction and developing skills in certain areas through certain integrated 9 classroom and laboratory instruction, supervised agricultural experiences, and leadership experiences and involvement in student organizations; establishing the 10 11 Maryland Agricultural Education Grant Program to increase access to agricultural 12 education in the State; requiring the State Department of Education to implement 13 and administer the Program; requiring the Department to employ an individual to 14 act as a content leader for agricultural education and to administer the Program; 15 authorizing the Department to award grants to certain entities for certain purposes; 16 requiring the Governor, for a certain fiscal year and each fiscal year thereafter, to 17 include in the annual budget bill a certain appropriation to the Program; defining a 18 certain term; and generally relating to agricultural education programs in public 19 schools.
