Mr. RUIZ introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To authorize the Secretary of Health and Human Services, acting through the Director of the Center for Mental Health Services of the Substance Abuse and Mental Health Services Administration, to award grants to implement innovative approaches to securing prompt access to appropriate follow-on care for individuals who experience an acute mental health episode and present for care in an emergency department, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Improving Mental
3 Health Access from the Emergency Department Act of
4 2019”.

5 **SEC. 2. SECURING APPROPRIATE FOLLOW-ON CARE FOR**
6 **ACUTE MENTAL HEALTH ILLNESS AFTER AN**
7 **EMERGENCY DEPARTMENT ENCOUNTER.**

8 The Public Health Service Act is amended by insert-
9 ing after section 520J of such Act (42 U.S.C. 290bb–31)
10 the following new section:

11 **“SEC. 520J-1. SECURING APPROPRIATE FOLLOW-ON CARE**
12 **FOR ACUTE MENTAL HEALTH ILLNESS AFTER**
13 **AN EMERGENCY DEPARTMENT ENCOUNTER.**

14 “(a) IN GENERAL.—The Secretary, acting through
15 the Director of the Center, may award grants on a com-
16 petitive basis to qualifying health providers to implement
17 innovative approaches to securing prompt access to appro-
18 priate follow-on care for individuals who experience an
19 acute mental health episode and present for care in an
20 emergency department.

21 “(b) ELIGIBLE GRANT RECIPIENTS.—In this section,
22 the term ‘qualifying health provider’ means a health care
23 facility licensed under applicable law that—

24 “(1) has an emergency department;

25 “(2) is staffed by medical personnel (such as
26 emergency physicians, psychiatrists, psychiatric reg-

1 istered nurses, mental health technicians, clinical so-
2 cial workers, psychologists, and therapists) capable
3 of providing treatment focused on stabilizing acute
4 mental health conditions and assisting patients to
5 access resources to continue treatment in the least
6 restrictive appropriate setting; and

7 “(3) has arrangements in place with other pro-
8 viders of care that can provide a full range of medi-
9 cally appropriate, evidence-based services for the
10 treatment of acute mental health episodes.

11 “(c) USE OF FUNDS.—A qualifying health provider
12 receiving funds under this section shall use such funds to
13 create, support, or expand programs or projects intended
14 to assist individuals who are treated at the provider’s
15 emergency department for acute mental health episodes
16 and to expeditiously transition such individuals to an ap-
17 propriate facility or setting for follow-on care. Such use
18 of funds may support the following:

19 “(1) Expediting placement in appropriate facili-
20 ties through activities such as expanded coordination
21 with regional service providers, assessment, peer
22 navigators, bed availability tracking and manage-
23 ment, transfer protocol development, networking in-
24 frastructure development, and transportation serv-
25 ices.

1 “(2) Increasing the supply of inpatient psy-
2 chiatric beds and alternative care settings such as
3 regional emergency psychiatric facilities.

4 “(3) Use of alternative approaches to providing
5 psychiatric care in the emergency department set-
6 ting, including through tele-psychiatric support and
7 other remote psychiatric consultation, implementa-
8 tion of peak period crisis clinics, or creation of psy-
9 chiatric emergency service units.

10 “(4) Such other activities as are determined by
11 the Secretary to be appropriate, consistent with sub-
12 section (a).

13 “(d) APPLICATION.—A qualifying health provider de-
14 siring a grant under this section shall prepare and submit
15 an application to the Secretary at such time and in such
16 manner as the Secretary may require. At a minimum, the
17 application shall include the following:

18 “(1) A description of identified need for acute
19 mental health services in the provider’s service area.

20 “(2) A description of the existing efforts of the
21 provider to meet the need for acute mental health
22 services in the service area, and identified gaps in
23 the provision of such services.

1 “(3) A description of the proposed use of funds
2 to meet the need and gaps identified pursuant to
3 paragraph (2).

4 “(4) A description of how the provider will co-
5 ordinate efforts with Federal, State, local, and pri-
6 vate entities within the service area.

7 “(5) A description of program objectives, how
8 the objectives are proposed to be met, and how the
9 provider will evaluate outcomes relative to objectives.

10 “(e) AUTHORIZATION OF APPROPRIATIONS.—To
11 carry out this section, there is authorized to be appro-
12 priated \$15,000,000 for each of fiscal years 2021 through
13 2025.”.
