## A BILL

- To require the Secretary of Veterans Affairs to submit to Congress certain reports relating to the health care and treatment provided by the Department of Veterans Affairs to women veterans, and for other purposes.

#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Caring For Our5 Women Veterans Act".

# SEC. 2. REPORT ON LOCATIONS WHERE WOMEN VETERANS ARE USING HEALTH CARE FROM DEPART MENT OF VETERANS AFFAIRS.

4 (a) IN GENERAL.—Not later than 90 days after the
5 date of the enactment of this Act, and annually thereafter,
6 the Secretary of Veterans Affairs shall submit to the Com7 mittee on Veterans' Affairs of the Senate and the Com8 mittee on Veterans' Affairs of the House of Representa9 tives a report on the use by women veterans of health care
10 from the Department of Veterans Affairs.

(b) ELEMENTS.—Each report required by subsection(a) shall include the following information:

13 (1) The number of women veterans who reside14 in each State.

15 (2) The number of women veterans in each
16 State who are enrolled in the system of patient en17 rollment of the Department established and operated
18 under section 1705(a) of title 38, United States
19 Code.

20 (3) Of the women veterans who are so enrolled,
21 the number who have received health care under the
22 laws administered by the Secretary at least one time
23 during the one-year period preceding the submittal
24 of the report.

(4) The number of women veterans who have
 been seen at each medical facility of the Department
 during such year.

5 veterans have had at each such facility during such

7 (6) If known, an identification of the medical
8 facility of the Department in each Veterans Inte9 grated Service Network with the largest rate of in10 crease in patient population of women veterans as
11 measured by the increase in unique women veteran
12 patient use.

(7) If known, an identification of the medical
facility of the Department in each Veterans Integrated Service Network with the largest rate of decrease in patient population of women veterans as
measured by the decrease in unique women veterans
patient use.

(a) IN GENERAL.—Not later than 90 days after the
date of the enactment of this Act, and annually thereafter,
the Secretary of Veterans Affairs shall submit to the Committee on Veterans' Affairs of the Senate and the Com-

mittee on Veterans' Affairs of the House of Representa tives a report on the use by the Department of Veterans
 Affairs of general primary care clinics, separate but
 shared spaces, and women's health centers as models of
 providing health care to women veterans.

6 (b) ELEMENTS.—Each report required by subsection7 (a) shall include the following:

8 (1) The number of facilities of the Department
9 that fall into each model described in subsection (a),
10 disaggregated by Veterans Integrated Service Net11 work and State.

(2) A description of the criteria used by the Department to determine which such model is most appropriate for each facility of the Department.

(3) An assessment of how the Department decides to make investments to upgrade facilities to
the next higher-level model.

(4) A description of what, if any, plans the Department has to upgrade facilities from the lowestlevel model, general primary care clinics, to another
model.

(5) An assessment of whether any facilities
could be upgraded to the next higher-level model
within planned investments under the strategic capital investment planning process of the Department.
