- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 18 That the Laws of Maryland read as follows:

- 21 (a) (1) In this subtitle, "elected member" means a voting member elected under
- 22 subsection (d) or (e) of this section or a member appointed to an elected position on the
- 23 county board under subsection (e)(3) of this section.
 - (2) "Elected member" does not include the nonvoting student member



- 1 selected under subsection (f) of this section.
- 2 (b) The Allegany County Board consists of:
- 3 (1) Five elected members; and
- 4 (2) One nonvoting student member, who is to advise the other members of the county board on the viewpoint of students who attend Allegany County public schools.
- 6 (c) An individual nominated for membership as an elected member on the county 7 board shall be a qualified voter and a resident of Allegany County for at least 1 year before 8 the election.
- 9 (d) The elected members of the Allegany County Board shall be elected:
- 10 (1) At a general election as required by this subsection or as provided under 11 subsection (e) of this section; and
- 12 (2) From Allegany County at large.
- 13 (e) (1) Each elected member serves for a term of 4 years beginning on January 14 2 after the member's election and until a successor is elected and qualifies. If January 2 is 15 a legal holiday, the term begins on the first day after January 2 that is not a legal holiday.
- 16 (2) The terms of elected members are staggered as required by the terms 17 of the members serving on the county board on July 1, 1978.
- 18 (3) Except as provided in paragraph (4) of this subsection, the [Governor]
 19 ALLEGANY COUNTY COMMISSIONERS shall appoint a [new member] QUALIFIED
 20 INDIVIDUAL to fill any vacancy [of] IN an elected member's position on the board for the
 21 remainder of that term and until a successor is elected and qualifies.
- 22 (4) If a vacancy occurs before the date that is 10 days prior to the filing 23 deadline for candidates for the primary election that is held in the second year of the term, 24 the individual appointed under paragraph (3) of this subsection shall serve only until a 25 successor is elected by the voters at the time of the next general election.
- 26 (5) Candidates for the vacated office may be nominated at a primary election in the same manner as for any other position on the county board.
- When more than one member of the board is to be elected at an election and the terms of the offices to be filled at the election vary, the elected candidate receiving the greater number of votes shall fill the office with the longer term.
- 31 (7) The candidate receiving the vacated position shall take office as soon as 32 possible after the election, and shall continue to serve for the remainder of the vacated term 33 and until a successor is elected and qualifies.

- 1 (8) Except as provided in this subsection, an election to fill a vacancy on 2 the Allegany County Board of Education shall be governed by §§ 8–801 through 8–806 of 3 the Election Law Article.
- 4 (9) The Allegany County Board of Supervisors of Elections may adopt 5 regulations to implement this subsection.
- $\,\,$ SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July $\,7\,$ $\,$ 1, 2020.
