Solid Waste Management – Prohibition on Releasing a Balloon Into the Atmosphere

4 FOR the purpose of prohibiting a person from knowingly and intentionally releasing or $\mathbf{5}$ causing to be released, or organizing the release of, a certain balloon into the 6 atmosphere; requiring the Department of the Environment to enforce this Act; 7 authorizing the Department to delegate certain enforcement authority to a certain 8 unit, officer, or official of a local government; requiring a certain unit, officer, or 9 official of a local government with delegated enforcement authority to report certain 10 violations to the Department; establishing a civil penalty for a violation of this Act; 11 defining certain terms; providing for the application of this Act; and generally 12relating to a prohibition on releasing a balloon into the atmosphere.

10 (3) AN ENFORCEMENT UNIT, OFFICER, OR OFFICIAL OF A LOCAL 11 GOVERNMENT WITH DELEGATED AUTHORITY SHALL REPORT EACH VIOLATION 12 UNDER THIS SECTION TO THE DEPARTMENT.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 14 October 1, 2020.
