Ms. SCANLON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2546) to designate certain lands in the State of Colorado as components of the National Wilderness Preservation System, and for other purposes; providing for consideration of the joint resolution (H.J. Res. 79) removing the deadline for the ratification of the equal rights amendment; and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of

1 the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 2546) to designate certain lands
3 in the State of Colorado as components of the National
4 Wilderness Preservation System, and for other purposes.
5 The first reading of the bill shall be dispensed with. All
6 points of order against consideration of the bill are waived.
7 General debate shall be confined to the bill and amend-
8 ments specified in this section and shall not exceed one
9 hour equally divided and controlled by the chair and rank-
10 ing minority member of the Committee on Natural Re-
11 sources. After general debate the bill shall be considered
12 for amendment under the five-minute rule. In lieu of the
13 amendment in the nature of a substitute recommended by
14 the Committee on Natural Resources now printed in the
15 bill, an amendment in the nature of a substitute consisting
16 of the text of Rules Committee Print 116–50 shall be con-
17 sidered as adopted in the House and in the Committee
18 of the Whole. The bill, as amended, shall be considered
19 as the original bill for the purpose of further amendment
20 under the five-minute rule and shall be considered as read.
21 All points of order against provisions in the bill, as amend-
22 ed, are waived. No further amendment to the bill, as
23 amended, shall be in order except those printed in the re-
24 port of the Committee on Rules accompanying this resolu-
25 tion. Each such further amendment may be offered only

1 in the order printed in the report, may be offered only
2 by a Member designated in the report, shall be considered
3 as read, shall be debatable for the time specified in the
4 report equally divided and controlled by the proponent and
5 an opponent, shall not be subject to amendment, and shall
6 not be subject to a demand for division of the question
7 in the House or in the Committee of the Whole. All points
8 of order against such further amendments are waived. At
9 the conclusion of consideration of the bill for amendment
10 the Committee shall rise and report the bill, as amended,
11 to the House with such further amendments as may have
12 been adopted. The previous question shall be considered
13 as ordered on the bill, as amended, and on any further
14 amendment thereto to final passage without intervening
15 motion except one motion to recommit with or without in-
16 structions.

17 SEC. 2. Upon the adoption of this resolution it shall
18 be in order to consider in the House the joint resolution
19 (H.J. Res. 79) removing the deadline for the ratification
20 of the equal rights amendment. All points of order against
21 consideration of the joint resolution are waived. The
22 amendment in the nature of a substitute recommended by
23 the Committee on the Judiciary now printed in the joint
24 resolution shall be considered as adopted. The joint resolu-
25 tion, as amended, shall be considered as read. All points

1 of order against provisions in the joint resolution, as
2 amended, are waived. The previous question shall be con-
3 sidered as ordered on the joint resolution, as amended,
4 and on any further amendment thereto, to final passage
5 without intervening motion except: (1) one hour of debate
6 equally divided and controlled by the chair and ranking
7 minority member of the Committee on the Judiciary; and
8 (2) one motion to recommit with or without instructions.

9 SEC. 3. House Resolution 842 is hereby adopted.

10 SEC. 4. On any legislative day during the period from
11 February 14, 2020, through February 24, 2020—

12 (a) the Journal of the proceedings of the previous day
13 shall be considered as approved; and

14 (b) the Chair may at any time declare the House ad-
15 journed to meet at a date and time, within the limits of
16 clause 4, section 5, article I of the Constitution, to be an-
17 nounced by the Chair in declaring the adjournment.

18 SEC. 5. The Speaker may appoint Members to per-
19 form the duties of the Chair for the duration of the period
20 addressed by section 4 of this resolution as though under
21 clause 8(a) of rule I.
