#### A BILL

To require U.S. Customs and Border Protection to expand the use of non-intrusive inspection systems at land ports of entry.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Non-Intrusive Inspec-
- 5 tion Expansion Act".

#### SEC. 2. USE OF NON-INTRUSIVE INSPECTION SYSTEMS AT 2 LAND PORTS OF ENTRY. 3 (a) FISCAL YEAR 2026.—Using non-intrusive inspection systems acquired through previous appropriations 5 Acts, beginning not later than September 30, 2026, U.S. Customs and Border Protection shall use non-intrusive in-7 spection systems at land ports of entry to scan not fewer 8 than-9 (1) 40 percent, cumulatively, of passenger vehi-10 eles entering the United States through land ports 11 of entry; and 12 (2) 90 percent, cumulatively, of commercial ve-13 hicles entering the United States through land ports 14 of entry. 15 (b) Subsequent Fiscal Years.—Beginning in fiseal year 2027, U.S. Customs and Border Protection shall use non-intrusive inspection systems at land ports of entry to reach the next projected benchmark for incremental scanning of passenger and commercial vehicles entering the United States at such ports of entry. 21 (e) Briefing.—Not later than May 30, 2026, the Commissioner of U.S. Customs and Border Protection shall brief the Committee on Homeland Security and Governmental Affairs of the Senate and the Committee on Homeland Security of the House of Representatives re-
