U.S. GOVERNMENT INFORMATION

> To amend title 10, United States Code, to provide for the issuance of the Gold Star Installation Access Card to the surviving spouse, dependent children, and other next of kin of a member of the Armed Forces who dies while serving on certain active or reserve duty, to ensure that a remarried surviving spouse with dependent children of the deceased member remains eligible for installation benefits to which the surviving spouse was previously eligible, and for other purposes.

# A BILL

To amend title 10, United States Code, to provide for the issuance of the Gold Star Installation Access Card to the surviving spouse, dependent children, and other next of kin of a member of the Armed Forces who dies while serving on certain active or reserve duty, to ensure that a remarried surviving spouse with dependent children of the deceased member remains eligible for installation benefits to which the surviving spouse was previously eligible, and for other purposes. Be it enacted by the Senate and House of Representa tives of the United States of America in Congress assembled,

## **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Gold Star Family Sup-5 port and Installation Access Act of 2017".

#### 6 SEC. 2. FINDINGS.

7 Congress makes the following findings:

8 (1) Since World War I, the gold star symbol
9 has been used by American families to honor mem10 bers of the Armed Forces who have given their lives
11 in service to the Nation.

(2) Surviving families of deceased members of
the Armed Forces confront many challenges, often
made worse by policies that fail to compassionately
honor the memory of their loved one's service and
sacrifice to the Nation.

17 (3) There is an obligation to ensure that the
18 Gold Star family connections to the military commu19 nity remain an eternal bond providing strength and
20 comfort to surviving family members and to those
21 still serving.

(4) Individual military services have recognized
the need to provide installation access to Gold Star
families to attend memorial events, visit gravesites,

1	and access other benefits for which family members
2	are eligible and entitled.
3	(5) Surviving families of deceased members of
4	the Armed Forces relocate to other parts of the
5	country, often far away from the service installation
6	where their loved one last served.
7	(6) Current Department of Defense policy re-
8	scinds on-base benefits to surviving spouses of de-
9	ceased service members who remarry, even when de-
10	pendent children under the guardianship of the sur-
11	viving spouse remain eligible for benefits, effectively
12	rendering these benefits inaccessible by the children
13	of the deceased member.

8 "(b) ISSUANCE TO OTHER NEXT OF KIN AUTHOR-9 IZED.—At the discretion of the Secretary concerned, the 10 Secretary concerned may provide the Gold Star Installa-11 tion Access Card to the parents and other next of kin of 12 a deceased member of the armed forces described in sec-13 tion 1126(a) of this title.

14 "(e) SERVICE-WIDE ACCEPTANCE OF ACCESS 15 CARD.—The Secretaries concerned shall work together to ensure that a Gold Star Installation Access Card issued 16 by one armed force is accepted for access to military in-17 stallations under the jurisdiction of another armed force. 18 19 "(d) PROTECTION OF INSTALLATION SECURITY.-In 20 developing, issuing, and accepting the Gold Star Installa-21 tion Access Card, the Secretary concerned may take such 22 measures as the Secretary concerned considers nec-23 essary-

24 "(1) to prevent fraud in the procurement or use
25 of the Gold Star Installation Access Card;

"(2) to limit installation access to those areas
 of the installation that provide the services and ben efits for which the recipient of the Gold Star Instal lation Access Card is entitled or eligible; and

5 "(3) to ensure that the availability and use of
6 the Gold Star Installation Access Card does not ad7 versely affect military installation security.

8 "(e) TERMINATION.—The Gold Star Installation Ac-9 cess Card for the widow and dependent children of a de-10 ceased member of the armed forces shall remain valid for 11 the life of the widow or child, regardless of subsequent 12 marital status of the widow, subject to periodic renewal 13 as determined by the Secretary concerned to ensure mili-14 tary installation security.".

EXTENSION OF COMMISSARY AND EXCHANGE BEN-2 EFITS FOR REMARRIED SPOUSES WITH DE-3 PENDENT CHILDREN. 4 (a) BENEFITS.—Section 1062 of title 10, United 5 States Code, is amended— 6 (1) by striking "The Secretary of Defense" and 7 inserting the following: "(a) CERTAIN UNREMARRIED FORMER SPOUSES.— 8 The Secretary of Defense"; and 9 10 (2) by adding at the end the following new sub-11 section: 12 "(b) CERTAIN REMARRIED SURVIVING SPOUSES.— 13 The Secretary of Defense shall prescribe such regulations as may be necessary to provide that a surviving spouse 14 of a deceased member of the armed forces, regardless of 15 16 the marital status of the surviving spouse, who has guardianship of dependent children of the deceased member is 17 entitled to use commissary stores and MWR retail facili-18 19 ties to the same extent and on the same basis as the unremarried surviving spouse of a member of the uni-20 21 formed services.". 22 (b) CONFORMING AMENDMENTS.—Section 1062 of 23 title 10, United States Code, is further amended— 24 (1) by striking "commissary and exchange
